VASQUEZ, J

1. Your Affiant, John Vasquez, is a sworn Colorado Peace Officer and a Detective for the Alamosa Police Department. I have compiled the information in this report during the course of an official criminal investigation, by speaking with law enforcement officers, by speaking with citizen witnesses, by reviewing official law enforcement reports, and my personal observations. All locations referred to are in the City and County of Alamosa, State of Colorado, unless specifically noted.
2. On July 14, 2022, at approximately 1814 hours (6:14 pm), I completed an alcohol compliance check with restaurants and bars. I enlisted the aid of Joseph Daigle and Taylor Isham, Criminal Investigators with Colorado Department of Revenue, Liquor and Tobacco. They provided the UC (Undercover operative), a person under the age of 21, and the money for purchase of the alcohol.
3. The UC went to the Thai Hut, 716 Main Street, at approximately 1912 hours (7:12 pm). The UC used Callyo (audio transmitter and recorder) which was audio recorded and attached to this case file. In accordance with rules of evidence, an examination of the original recording of this contact is the best evidence of its content.
Summary of the contact:

- The UC is greeted and asked how many to be seated and the UC responds two.
 - The UC is seated and a short time later is waited on. The UC asks for beer and the server informed the UC of the beer choices.
 - The UC asked for a bottle of Bud Light and the server acknowledged.
 - Approximately over a minute later the server returned and served the UC the Bud Light.
 - Over the next minute the UC informed the server he needed to leave and wanted to pay for the Bud Light.
 - The server told the UC to finish the beer as there was no rush.
 - The UC paid for the Bud Light with a marked \$20.00 and left the Thai Hut.
4. I then went and contacted the owner of the Thai Hut who I identified as Sirorat Vienmanapun, date of birth [REDACTED], and will be referenced as Siri throughout. I explained to Siri that there was an underage person who was just sold a Bud Light from her establishment and paid with a \$20.00.
5. I asked Siri for the \$20.00 and gave her the change that was given to the UC. Siri explained that it was another server who just started who made the sale. The server was identified as Surachai

Wienmanpun, date of birth [REDACTED], and will be referenced as Surachai throughout.

6. Surachai said he was helping out his sister Siri and was from Canada. He explained, in Canada the age to drink is 19 and the UC tricked him. I explained to Surachai that it was his responsibility to make sure of the legal age.
7. Surachai was issued summons #E011222 for City Ordinance 11-51 Liquor-Sale to Minor. I then explained to Siri that she will be contacted at a later date for a Show Cause hearing with the City of Alamosa. Siri did not have any questions.
8. End of the report, this has been a summary of the incident, further reports to follow.
