Background

Attached for your review and information is the Monthly Financial Report for August 2018. The report is for all City Funds. The report shows the fiscal and period activity within the same report, making it easier to read and understand the City's current position. The accounts have been reconciled to the bank.

General Fund Revenue

The City received payment for the 1.2% Sales Tax from the County in the amount of \$312,159.96. Total 1.2% Sales tax for the year is \$2,263,243.43. Sales Tax (general) revenue for the month total was \$253,431.64. General Sales Tax for the year total is \$1,807,642.47. Total revenue this month was \$831,849.36 and for the year was \$7,686,450.99.

General Fund Expenditures

Expenditures for the month were \$1,208,935.35. Year to date expenditures were \$7,358,520.25.

Enterprise Fund Revenue

Revenue for the Enterprise Fund for the month was \$437,371.99 and year to date was \$4,658,890.33.

Enterprise Fund Expenditures

Expenditures for the Enterprise Fund for the month were \$383,670.45. Year to date expenditures are \$2,890,863.36.

Retail Sales Tax Licenses

There were 1 sales tax licenses added and 0 terminated this month.
