Public Works Department

Streets: Continued with daily sweeping operations. Bladed all gravel roads. Bladed all Downtown Alley's. Conducted Large Item Pick up for a week in May. Hauled brush from Recycle Yard pit. (1 day, 10 hours) Performed routine maintenance to our equipment. Sign repairs. Conducted traffic control and flagging operations for 2nd to 1st Street sewer tie in. Placed gravel on Edison and San Juan shoulders from 17th to 20th Street. Painted all Permit Parking areas in Adam State University. Installed all "Parking by City Permit Only" signs. Repaired storm drain manhole #2 and Carson. Inspected levee for possible issues. Repaired beaver holes in levee. Replaced planters removed for Ice Fest to Main Street. Conducted road closure for Police Memorial on 4th Street. Facilitated paving of Second Street entrance of Cole Park. Began Concrete Replacement Program. Cleaned up downed trees and limbs after high winds. Assisted with sinkhole repair at 300 Hunt Avenue. Patched open cuts with hot mix. Continued identifying and marking soft spots for locates and repairs. Conducted traffic counts requested by streets committee. Attended streets committee meetings. Worked with GIS Specialist on Streets Committee Presentations. Assisted with Public Works Director Interviews. Conducted interviews for seasonal help.

Solid Waste: Commercial waste hauled totaled 317.24 T.; residential waste hauled totaled 249.53 T. Medical Waste totaled 5.01. Thirty special pick-ups were completed. Eight 96 gal toters, two, 64 gal toters and five yard waste toters were delivered. Seven toters and four dumpsters were repaired.

Recycling: A total of 78 bales of various materials were made. 54 bales were shipped. A total of 6 tons of glass was processed. Land fill savings totaled \$471.96. Five Yard Waste toters delivered.

Building Inspection: Fifteen building permits were issued for a total valuation of \$17,280.34. Building Permit fees totaled \$9,095.64 and construction use tax totaled \$2, 731.31. Plan review fees totaled \$1,500.00. A total of 20 various inspections were conducted. There were 4 certificate of occupancies issued. A total of seven general contractor licenses and one limited contractor license was issued.

Water: Water pumped for municipal use totaled 77,850,000 gallons. Water treatment plant production totaled \$62,154,528 gallons. There were sixty nine meter re-reads. Turn on/ turn offs and occupant changes totaled 69. Took Bac-T's for the State. Worked on flushing dead end water mains. Checked all storm lift stations. Q-3 Contracting finished the installation of the new has main and services. Xcel finished the installation of the new power poles, moved power cables and removed the old poles on First Street. Gardner Excavating finished installing new 6 inch water main at 12th and La Due up to 9th and La Due and patched the trench. Received quotes to replace the VFD drive at Murphy Well. Alpine Electric will replace the drive. (It is six to eight weeks out) Repaired three service lines that were hit by contractors on First Street as they were lowered phone lines,

Water Treatment Facility: Water produced= 62,154,528 gal. Average CL2= 1.23 mg/l Average Raw Arsenic= 41.4 ppb Average Finished Arsenic= 7.1 ppb (MCL=10ppb) Coagulant used (Ferric Chloride)= 1,860 gal. Sodium Hypochlorite Used (Chloride)= 1,162 gal. Average Recovery Ratio=91.7%

Wastewater: Total discharge for the month was 41.89 million gallons. Collected and sent out all routine monthly samples. Cleaned and inspected screen and press. Collected and ran all routine

monthly samples. Cleaned and inspected screen and press. Vision Medical worked on the HVAC System. Went to SDC Lab to go over the SAR Calculation. Sprayed down both clarifiers. Helped fixed water service that was hit on First Street.

Sewer: Fifty nine sanitary sewers were inspected; 12 were unplugged. Seventeen were checked at customer's requests. 0 were cleaned and flushed. All lift stations were checked daily. Flushed dead end sewer lines. Cleaned Murphy, McDonald's, and 20th Street lift stations. Still working on the HVAC system at the Waste Water Treatment Plant. Did locates for new fiber optic line going to the Waste Water Treatment Plant. Repaired collection line and storm line on the 300th block of Hunt after it caused the street to cave in. Sent the B-10 Vac-truck to Denver to have the high pressure water pump replaced. We were without the truck for the week. It is now back in service.

East Alamosa: Water supplied to East Alamosa totaled 4,568,417 gallons. Six sanitary sewers were checked for plugs, three unplugged. Did re-reads for Sally. Pulled the pumps at Price, McKinney, McQuerry and Rodeo Lift Stations. Cleaned impellers of debris. Cleaned lift stations at Sunny Side Lane, Blanca Vista and Price Ave. Changed oil in the motors of 2 well houses. Did locates for fiber along Highway 17 and McKinney. Worked on Sunny Side motor which needs to be sent off for further repair. Got it back, but it was still leaking oil so we sent it back.

Below is a statement regarding major issues covered by the City IT Department:

May 2019 Report

- At the beginning of May, IT coordinated a training on the new phone system with the installers (High Country Technologies). Representatives from every department and division were shown how to access voicemails, set up greetings, and use other basic functions of the new phone system.
- The first few weeks of May IT was heavily involved in the transition of the new phone system, specifically configuring Mitel Mobility, Chronicall and customizing soft buttons on handsets. Mitel Mobility extends the call function of their desk phone to be extended to a cell phone. Using an app, users can answer and make calls as if they were sitting at their desk from anywhere in the world. This also make functions like setting up user states or listening to voicemails much easier. IT will roll out this feature to more users over the coming weeks. Chronicall is a phone recording system that works on all City phones from “cradle to grave” - meaning that calls are recorded from the moment a phone is picked up from the cradle (or speaker phone is initiated) to the moment the call is disconnected.

Although this is similar to the previous recording system, calls are now being recorded for every phone call the City handles, not just the Police Department. Lastly, IT worked with high call volume users to better customize handset features. Shortcuts were added for other extensions and commonly used functions.

- IT finalized our E-911 designations. Each building will now report a physical address to 911 services. Previously, if a call was placed to 911 from any City phone, the address would show as 300 Hunt Ave. In example, now if the Rec Center calls 911, the 2222 Old Sanford road address will show.
- IT made multiple changes to the City firewall throughout the phone system installation. The updates added functionality for the Mitel Mobility feature while maintaining a high standard of security.
- 2019 marks the second year of the IT Internship program coordinated through the Boys and Girls Club and the Alamosa High School Teen Tech Program. Two students were recommended by the school system to join this year. Each intern is goes through the same onboarding process as a traditional IT Technician. The interns are tasked based on skill level and take part in operational helpdesk activities. The program is designed to give the aspiring technologists real world experience in an enterprise network, ranging from basic wiring to inventory management and troubleshooting.
- IT Department staff member, Brandon Gallegos, obtain a certification in Business Relationship Management. BRM is an arm in ITSM (IT Service Management) and part of the ITIL (IT Infrastructure Library) framework. A business relationship management professional works to deliver value to an organization by working with other departments (business partners) to formalize an IT strategy.
- IT worked with Jade Communications to identify and resolve a network outage. Jade found a fiber was severed near the Farm Park and quickly repaired the break.
- Part of routine network clean up and security best practices, IT changed the business production network wifi password. The City uses the wireless connection strictly for business production network devices. All other network traffic is directed to the "public" APL network.

- IT accepted and awarded a bid for a fiber buildout project. The fiber will splice in near the cemetery building and terminate at the wastewater treatment. A loop will be added to connect the recycling building. The project is for internal facing fiber with 24 strands.
- IT continued to work on the court audio equipment and resolved further issues with the recording device.
- Patched all City owned computers to the latest patch and vulnerability fixes from Microsoft. This monthly patching helps protect our computers from malicious software, resolve general windows issues/bugs, and provide access to new windows features.

In Monte Vista, we performed the following items:

- IT is moving into the newly built extension to the server room. This room allows for storage of computer equipment and the addition of a full rack. Servers from the primary rack will be moved over to give room for expansion and better balance the current resources.
- The cityofmontevista.com domain name ownership has been renewed for the next 8 years.
- IT met with Golf Board members and Staff Liaisons to discuss the current status of the golf course website. The site will continue to be managed by an external contractor.
- The City of Alamosa donated another Mobile Data Terminal (Toshiba Toughbook) to the City of Monte Vista Police Department. The laptops are valued at ~\$5000 per device (totalling ~\$45,000). The grant the hardware was purchased under stipulates that the laptops cannot be sold on the secondary market but must be used until inoperable or transferred to another agency.
- IT is working with CBI to resolve an issue where all units were receiving all messages. CBI will need to replace our current "pool TID" with individual station TIDs
- Patched all City owned computers to the latest patch and vulnerability fixes from Microsoft. This monthly patching helps protect our computers from malicious

software, resolve general windows issues/bugs, and provide access to new windows features.

Brian will utilize Cole Park to teach the proper fundamentals of mountain biking. You will be surprised how much you can learn about mountain biking without having to be in the mountains! Participants are responsible for bringing their own bikes (fancy mountain bikes not required!). There is only space for 6 participants in this class, so register today!

Youth Sports & Activities

- **Alamosa Youth Football (TACKLE):** Registration is open NOW through July 1st for boys and girls, grades 3 - 6. Participants are limited; register early to guarantee a spot.
- **Basketball Fundamentals:** Let's get back to basics! Kids are invited to join in strictly skill building practice sessions. There are no teams or games in this program; just practice sessions focused on the fundamentals of basketball.
- **Youth Baseball/Softball:** A couple spots are still open for ages 5-13 baseball/softball. Games have started and will continue through July 18th.

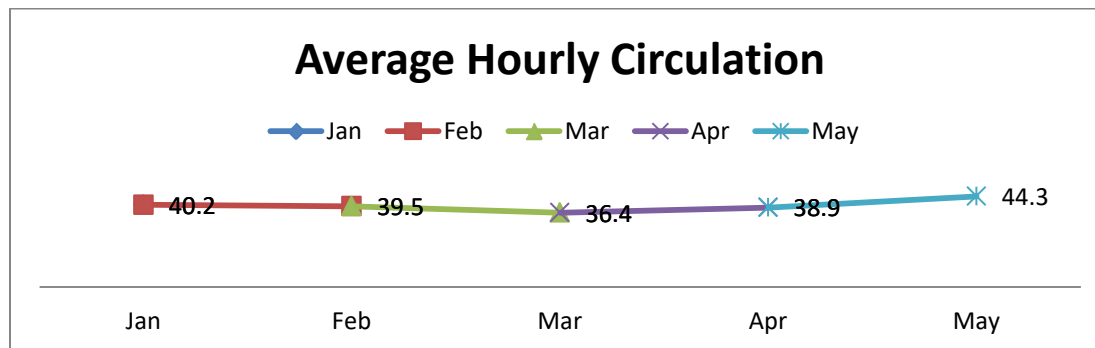
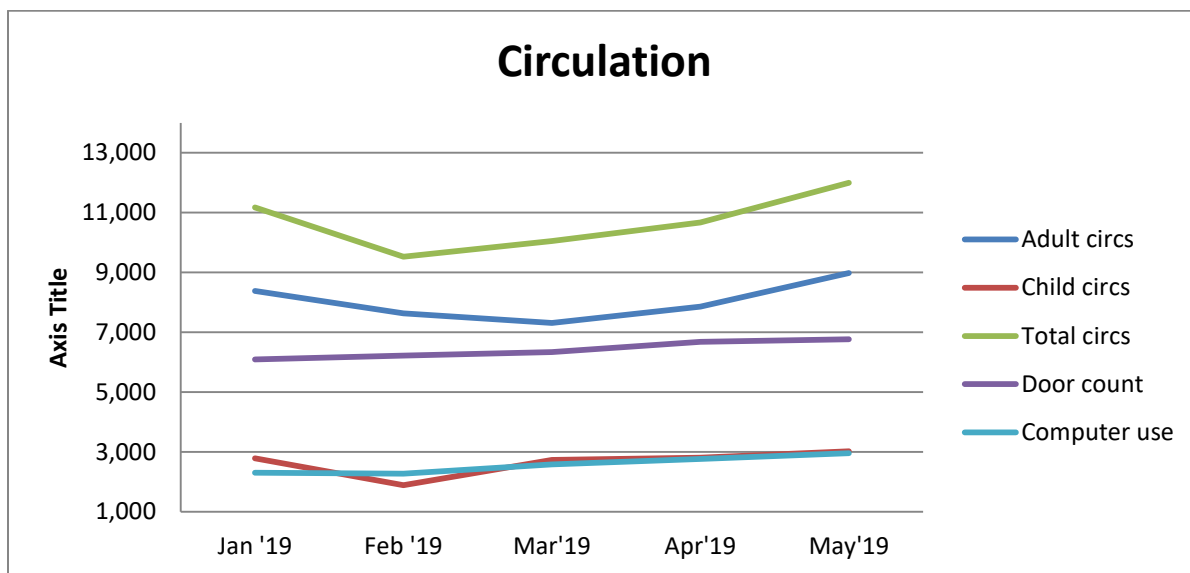

Collection Development:

May: Staff added 347 new materials to the library collection: 232 books, 51 magazines, 12 audiobooks and 50 DVDs. This process includes purchasing, cataloging, and material processing. 102 items were discarded.

Staff announcements.

May: Volunteers: We had a total of 127.5 volunteer hours this month. Patty Campbell and Leroy Espinoza, our faithful volunteers, work in the staff room doing miscellaneous jobs. Our SER National (Service, Employment, Redevelopment) Senior Trainee worked 98 hours. Holly had 4 teen volunteers help 2hrs with organizing the Summer Reading Program for June.

Children's Enrichment Activities (La Llave donation): We purchased a Weplay Wavy Tactile Path for children's events. Staff experienced how much the children enjoyed this portable walking path during the time we had the "Discover Health" exhibit in the library. From these donation funds we also purchased beads for our Read for Beads incentive program for the summer.

Colorado State Library grant: Our storybox project needed some books replaced. We were able to do some collection development purchasing for our Family Resource and nonfiction sections. A majority of the funds purchased early literacy books. Staff put together a 'Bird Watching Backpack' for our patrons to checkout with a portion of these funds. This was inspired by staff attending the bird watching event through a Parks & Recreation bird watching event and the positive reaction to the Colorado State Park backpack we have for circulation.

Community Involvement



- **May:** Of 16 "Storytime To Go Kits", we have had 7 more checkouts in May bringing the total checkouts to 154 since they were first available in August 2017.



- **May:** There are 109 children signed up for our Planting Seeds, 1,000 books program. In this program, as each child reads 100 books, they receive 1 free book. 6 children/parents have completed the program.



Checkout Colorado State backpacks

May: We advertised this program in April and had an immediate response. – 2 backpacks have been checked out 4 times in May. Checkout period is 7 days. 1 of the backpacks can be renewed if there are no patrons' holds waiting.



• **May:** Family, Friends and Neighbors program - 27 caregivers are signed up and all received Early Literacy Kits containing EL books, music, toys. We have 9 Spanish Literacy Kits in the community.



• **May:** “Paddington 2” – First time in a very long time we had no one show up for the movie. It was graduation night. Next showing will be June 14, 2019.



• **Grow Your Library story time event:**
May: Gary and Tina Mlodzik, from the ‘Grow Your Library/Kids Need to Read’ program, delivered *more* books for families of the SLV to take home during a special storytime event we hosted with them. 162 attended! 125 of those were children. We saw families we didn’t know we had in the valley. Each child took home up to 4 books each.



• **May:** The local Fiber group, “**Fiber Floozies**”, met in the Story Room. Usual attendance is 10-15 fiber enthusiasts. The group knits, weaves, spins, and crafts all things fiber. They share and teach each other new techniques and ideas. Planning for charity projects or events is also done at these meetings. The next meeting will be June 12, 2019. Anyone interested in any type of fiber arts is welcome.

• **Amanda Warman**, a Speech-Language Pathologist, is also using our facilities to work with families and their young children. She is accessing our ILL department to receive and send tools and books to help the children and parents she is working with.



• The **Historic Preservation Advisory Committee** meets the second Tuesday each month in the Local History Room.

• **The People First** group, persons with disabilities in the San Luis Valley, meets weekly, Sunday afternoons, in our Local History room.



- **May:** 583 children and parents attended the Tuesday & Friday story times, baby playtime sessions, four school tours and 'Grow Your Library/Kids Need to Read' story time. This was without Tuesday & Friday the last two weeks of May in order to allow Holly to get ready for the Summer Reading Programs in June.



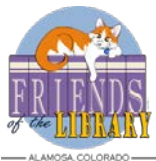

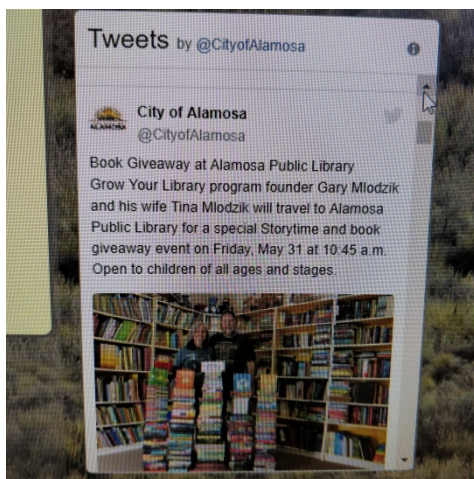
SLV Playdates Baby Time – Just when you think the group has disappeared... More recruits come! The group is now small but mighty. And by "mighty," I mean "consistent."

School Tours – I was lucky enough to give library tours and share a storytime session with FOUR school programs this month! We hosted Sanford Elementary's preschool program, as well as Rocky Mountain Head Start's preschool crew! Manassa Elementary and La Jara Elementary brought us their kindergarteners. All of the tours went well!

ALAMOSA CITY COUNCIL COUNCIL COMMUNICATION

Subject/Title:

Public Hearing and Second Reading, Ordinance No. 15-2019, an ordinance amending Division 4-2 of Chapter 21 of the *Code of Ordinances of the City of Alamosa* to better understand the application of the housing palette, and to decrease side setback requirements on certain lots in RM and RH zones as set forth in section 21-4-202(b).

Recommended Action:

Approve Ordinance No. 15-2019 on second reading.

Background:

This issue came to light when CRHDC, which owns a number of previously subdivided lots in the Montana Azul area, talked to the Public Works Department about building permits for those lots. The lots are large lots, classified as Suburban Lots under the new UDC. The UDC establishes a so-called “housing palette” in Division 4-2, setting forth lot and building standards for various types of construction, and particularly for single family home construction in the various zones as set forth in Section 21-4-202. The housing palette categorizes lots by the area of the lot as either Estate lots (>12,000 sf); Suburban lots (between 7,000 and 12,000 sf), and Town lots (between 4,500 and 7,000 sf).

CRHDC uses standard buildings that were designed to fit on the lots consistent with the prior code’s 7 ft. side setback. They do not comply with the UDC’s 10 ft. side setback for suburban lots. The prior code did not employ a housing palette, but rather varied setbacks based on the zoning district. In reviewing the housing palette concept in light of CRHDC’s situation, it became clear to staff that additional types of palettes were necessary for large lots (suburban lots) in areas zoned RH or RM, which are designed for greater density than areas zoned RL. Lot coverage limitations are not proposed to be adjusted by this amendment, but this amendment will allow for closer setbacks in these zones of higher density, which setbacks will be more consistent with existing development in such zones. Additionally, the side setbacks for ancillary buildings is increased from the current 3 ft. to 5 ft. for safety and aesthetic concerns.

Finally, in analyzing this issue, staff became aware of difficulties in applying the palette definitions. Todd Messenger, the attorney who drafted the UDC, provided some language that he is using in other versions of the UDC to clarify the application of the palette, and that language is added through this ordinance to help in applying the correct palette.

Issue Before the Council:

Does Council wish to approve the Ordinance amending the housing palette for single family residences on second reading?

Alternatives:

- 1) Approve the Ordinance on second reading;
- 2) Approve the Ordinance with changes to the setbacks (for example, keeping the current ancillary building side set back at 3 feet);
- 3) Decline to approve the Ordinance in whole or in part, and give staff further direction.

Fiscal Impact:

None.

Legal Opinion:

City Attorney will be available for comment if necessary.

Conclusion:

Approval of this Ordinance would give greater flexibility in site design for large lots in zones of higher density.

ORDINANCE NO. 15-2019

AN ORDINANCE AMENDING DIVISION 4-2 OF CHAPTER 21 OF THE CODE OF ORDINANCES OF THE CITY OF ALAMOSA TO BETTER UNDERSTAND THE APPLICATION OF THE HOUSING PALETTE, AND TO DECREASE SIDE SETBACK REQUIREMENTS ON CERTAIN LOTS IN RM AND RH ZONES AS SET FORTH IN SECTION 21-4-202(b)

WHEREAS, Alamosa's Uniform Development Code, codified in Chapter 21 of the *Code of Ordinances of the City of Alamosa*, establishes a so-called "housing palette" in Division 4-2, setting forth lot and building standards for various types of construction, and particularly for single family home construction in the various zones as set forth in Section 21-4-202; and

WHEREAS, the housing palette categorizes lots by the area of the lot as either Estate lots (>12,000 sf); Suburban lots (between 7,000 and 12,000 sf), and Town lots (between 4,500 and 7,000 sf); and

WHEREAS, prior to adoption of the UDC, certain areas of the City were subdivided, and certain of those subdivision lots large enough to classify as suburban lots under the UDC housing palette, and existing in areas zoned RM and RH, were developed with the then-existing side lot setbacks of 7 feet, rather than the 10 feet set back, with the owners planning additional consistent development for the future; and

WHEREAS, Because higher density is envisioned in RM and RH zones than in RL zones, Council considers it appropriate to apply the prior 7 foot side lot set back rather than the current 10 foot side lot setback for suburban lots in RM and RH zones, but keep the current 10 foot side lot setback for suburban lots in RL zones by making such a zoning distinction in Table 21-4-202(b); and

WHEREAS Council has determined that the housing palette concept would be better understood by addition of explanatory language to Section 21-4-202(b);

NOW THEREFORE BE IT ORDAINED by the City Council of Alamosa as follows:

Section 1. Amendment of Section 21-4-202. Section 21-4-202(b) is repealed and replaced to read as follows:

(b) *Lot and building standards; Differentiating among single-family housing types.* Table 21-4-202(b), Single-family detached lot and building standards, below, establishes five lot types for single-family detached dwelling units. To meet the requirements for any lot type, both the lot area and the lot width minimums must be met. For example:

(1) If a developer proposes a 7,300 sf. single-family lot that is 50 ft. wide, the lot would be classified as a "Town Lot" lot, but if the lot width is increased to 60 ft., the lot would be classified as a "Suburban Lot."

(2) If a developer proposes a 4,700 sf. single-family lot that is 45 ft. wide, the lot would be classified as a “Town Lot” (and could be accessed via street or alley), but if the same lot were only 40 ft. wide, it would be a “Town Lot” that must have alley access, as provided in Table 21-4-202B.

Section 3. General Repealer. All other acts, orders, ordinances, resolutions, or portions thereof in conflict with the sections adopted in this Ordinance, are hereby repealed to the extent of such conflict.

Section 4. Recording and Authentication. This ordinance, immediately upon its passage, shall be authenticated by the signatures of the Mayor and City Clerk, recorded in the City book of Ordinances kept for that purposes, and published according to law.

Section 5. Publication and Effective Date. This ordinance shall take effect ten (10) days after publication following final passage. Publication both before and after final passage shall

be by the title of this ordinance, which Council determines constitutes a sufficient summary of the ordinance, together with the statement that the full text of the ordinance is available for public inspection and acquisition on the City's website and in the office of the City Clerk.

Section 6. Declaration of Public Interest. This ordinance is necessary to preserve the peace, health, safety, welfare, and to serve the best interest of the citizens of the City of Alamosa, Colorado.

Section 7. Codification. The City Clerk is directed to codify the provisions of this ordinance in the *Code of Ordinances of the City of Alamosa* in substantially the same form as set forth herein.

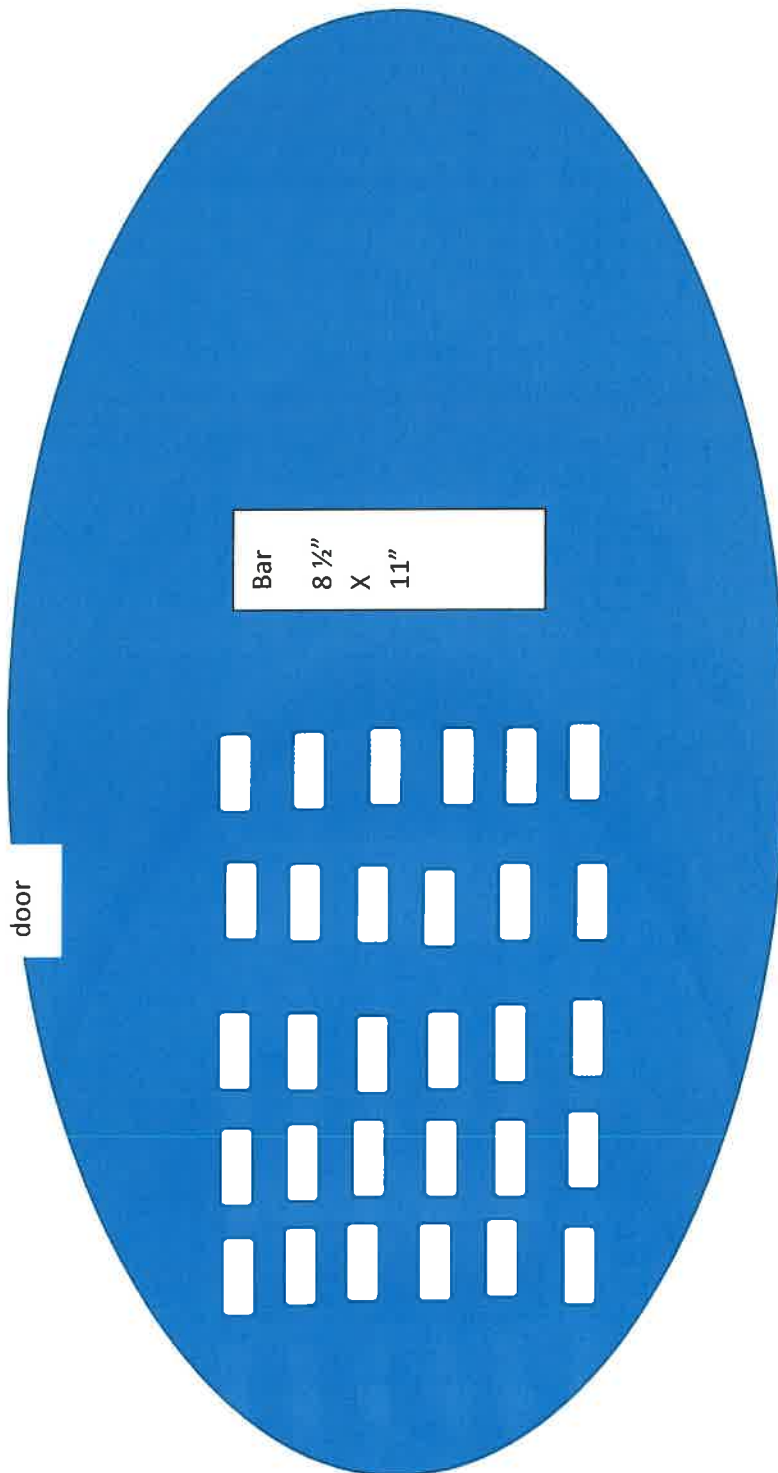
