Subject/Title:

Alfirio Martinez Residential Use from Non-conforming to Conforming Use and Subsequent Required Conditional Use Permit

Recommended Action:

That Council ratify the unanimous Planning Commission recommendation changing the Martinez Residential Use from a non-conforming to a conforming use and issue the Conditional Use Permit, including the waived maximum Building Coverage Ratio, thereby allowing them to construct their proposed 840 sf garage.

Background:

The existing house was constructed in 1926 and has been commercially zoned for at least 30 years. Previous zoning codes allowed for residential dwellings in CB by special review. Currently, single family dwellings are not permitted within CB zones, and though preexisting non-conforming uses are grandfathered in with the current UDC, alterations or extensions to non-conforming uses are not permitted. This meant that Mr. Martinez could not construct a garage on his property.

The UDC allows non-conforming uses to be converted to conforming uses. This process is found at Sec. 21-7-204. - Conversion of a nonconforming use to a conforming use -- which provides as follows:

(a) Generally. In many instances, nonconforming uses may be integral parts of the city's fabric, that is, its character and function, so their continuing existence promotes the city's policy of retaining existing businesses or protecting its character and neighborhoods. In these instances, the classification "nonconforming use" and resulting restriction on investment may not be what the community desires. As such, a nonconforming use may be made "conforming" pursuant to this Section in order to remove the potential stigma associated with the "nonconforming" designation.

Changing Mr. Martinez's residential use from non-conforming to a conforming use will allow Mr. Martinez the ability to not only add a garage which is the more immediate need, but he will be able to make other improvements to his residence in the future while still complying with other UDC requirements. The UDC requires certain aspects be taken into consideration to be eligible to convert a non-conforming to a conforming use and staff has indicated that this request meets those aspects and the Planning Commission unanimously agreed. The conversion must meet the standards set forth in Sec. 21-7-204 and also those for a conditional use set forth in Sec. 21-2-302. Both sections are attached for your reference.

The other aspect of Mr. Martinez's request relates to the maximum Building Coverage Ratio (BCR) that would not allow for a 840 sf garage because that would result in lot coverage of 45%, while the Code limits maximum lot coverage to 40%. Under Mixed Use zoning, the housing palette defaults to Town Lot, which are limited to 40% lot coverage. The uses within this block could be classified as mixed: 2 triplexes, 1 duplex, 1 office unit, 2 residential/commercial buildings, and 11 SFDs. While the housing palette would place a maximum building coverage ratio (BCR) 40%, current lot densities on the adjacent properties are 47.3% and 31.7%, and other properties in this

block have comparable ranges of building coverage, so the waiving of the BCR to allow the coverage to be 44.8% is not inconsistent with the development of the block.

Issue Before the Council:

Does Council wish to ratify the unanimous approval of Planning Commission to approve the requested Conversion from Non-conforming to Conforming Use and Conditional Use Permit as presented?

Alternatives:

- Council may choose to ratify the requested Conversion from Non-conforming to Conforming Use and Conditional Use Permit as presented.
- Council may choose to place the issue for public hearing on the next Council Meeting agenda and approve, amend, or deny the Conditional Use Permit after conducting a new public hearing.

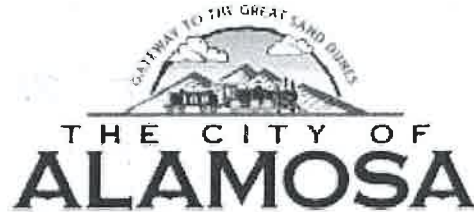
Conclusion:

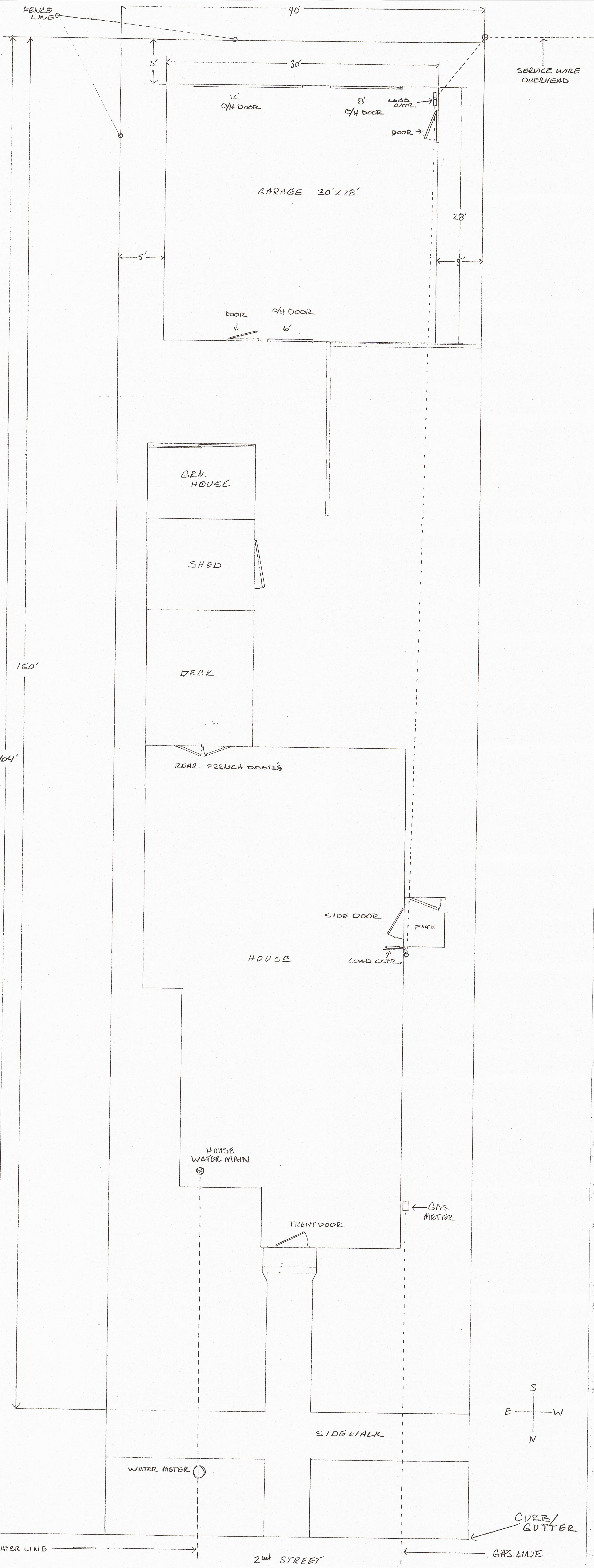

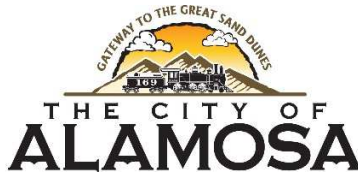

Date: August 5, 2019

BACKGROUND

The subject property is located at 616 Second Street, otherwise known as lot 21, block 17 Alamosa Addition 1. The site is currently improved with an existing single family dwelling (SFD) within a Commercial Business (CB) zone. The uses within this block could be classified as mixed: 2 triplexes, 1 duplex, 1 office unit, 2 residential/commercial buildings, and 11 SFDs.

The existing house was constructed in 1926 and has been commercially zoned for at least 30 years. Previous zoning codes allowed for residential dwellings in CB by special review. Currently, single family dwellings are not permitted within CB zones (*cf.* **Table 21-2-202A**), and though preexisting non-conforming uses are grandfathered in with the current UDC, alterations or extensions to non-conforming uses are not permitted (**Sec. 21-7-204a**).

Mr. Martinez contacted the City Building Inspector this May to inquire about adding a garage to his lot. The Building Inspector then informed him that the zoning did not permit him to construct the garage, but a major zoning map update was being planned at some point in the future. His block is included in the potential update and the rezoning should alleviate the issue. A few weeks later, direction had been passed along from a City Council Member to the City to help find a way to permit the use.

The applicant's lot is 6000 square feet (40'x150'). The existing coverage is 1,847sf out of 6,000sf (30.8%) as measured by the following, with sources in parentheses:

1457sf house footprint (County Assessor), 154sf deck (applicant), 138sf shed (applicant), and 98sf greenhouse (applicant)

ANALYSIS AND IMPACT

The completed Land Use Application was delivered to the Public Works Department on 8/8/2019. Per **Sec. 21-7-204**, any non-conforming use may be converted into a conforming use by meeting the approval criteria for a Conditional Use Permit (CUP) - specifically plan implementation, compatibility, and community need. Further requirements state that the non-conforming use should have minimal nonconformities and has been integrated into the function of its surrounding neighborhood or zone.

CUP Requirements:

Plan Implementation. The site location would support the Comprehensive Plan's *Downtown Periphery* and *Historic Town Site Residential* Visions.

Compatibility. The proposal will be compatible with surrounding uses. Most residential lots in this block are built out to a point that would exceed the current UDC regulations.

Community Need. The use could address a material need for the use in the community in the sense that it further develops and increases the property value and marketability of an older home within an older part of town, however this is difficult to quantify.

Additional Conversion Requirements

The use has minimal nonconformities and has been integrated into the function of its surrounding neighborhood or zone.

Typically, the proposed use still must meet the setback and lot coverage requirements for the underlying zone; however this creates conflicts with surrounding uses and would require the applicant to additionally apply for a variance because the lot does not meet the size requirements. Because the use is Residential, it is implicit that the housing palette would apply (versus **Table 21-4-301**).

Further, it is worth considering that the platted nature of the block would have made it a good candidate for an EN zone, at which point **Division 4-1** would allow for more flexibility in the lot setback requirements (but not density). On the other hand, the existing uses make it more appropriate for MU zoning. Under MU zoning, the housing palette defaults to Town Lot (**Table 21-4-202B**).

Finally, it needs to be considered that the applicant's site plan shows the garage at 840sf. The current coverage is 1,847sf. The site plan, if approved as is, would increase the lot coverage to 2,687sf – or 44.8% building coverage ratio. Current lot densities on the adjacent properties are 47.3% and 31.7%, and other properties in this block have comparable ranges of building coverage.

RECOMMENDATION

Planning Commission must decide if it wants to set the precedent for allowing expansion of non-conforming residential uses through the process laid out in **Sec. 21-7-204**. Under the current Code, there are only two ways to address this issue: the one being used here and a rezoning of the affected property. A bulk zoning map update is understood to be needed; however the timeline of this particular request would not fit with a large zoning map update and could only be accomplished by spot zoning.

It is the opinion of staff that the application be **approved** on the grounds that it conforms to the surrounding uses of the block even though the UDC does not permit single family dwellings within CB zones.

If Planning Commission chooses to approve of the application, staff suggests the following condition so as to be consistent with the UDC: That the subject property adheres to the housing palette of a Town Lot with Street Access (**Table 21-4-202B**). This would mean that the applicant's proposed garage has 5' setbacks from the sides and rear, a 10' separation between structures as well as a maximum building coverage ratio of 40%. The existing building coverage is 1,847sf out of 6,000sf (30.8%). This means that the garage can be no greater than 553sf (30'x18' or some similar configuration), or the applicant must remove enough existing coverage to accommodate the proposed garage. **Division 4-4** allows for some flexibility for lot and building standards, however **Sec. 21-4-402(b)** explicitly states that the objective is not to allow increases in the permissible building coverage.

Alternatively, Planning Commission may choose to apply the CB zone lot standards (**Division 3-3, Table 21-4-301**), which only requires a minimum landscape surface ratio (LSR) of 10% (**Table 21-3-301B**). This may create conflicts because the lot size does not meet the requirements, and these divisions explicitly do not apply to residential use. However, this may be the only way to allow the applicant to keep his current site plan.

Another option is follow the staff recommendation and require the applicant to go through a variance process. However, it is doubtful if a variance would even be allowed due to the non-conforming to conforming process requirements or that the variance would even be permissible regardless of the conforming status (**Sec. 21-8-702(b), (d)**).

Relevant Code:

Article VII. - Nonconformities

Sec. 21-7-101. - Purpose

- (a) **Generally.** The application of new regulations to existing development may create circumstances in which existing lot dimensions, density, intensity, land uses, buildings, structures, landscaping and buffering, lighting, parking areas, or signs do not strictly conform to the requirements of the new regulations. For existing lots or development (including uses, buildings, structures, and signs) that are "legally nonconforming," this Article sets out equitable rules for whether, when, and how the regulations of this UDC apply.
- (b) **Conversion of Nonconformities.** Generally, nonconforming uses, buildings, structures, and signs are not allowed to be enlarged, expanded, increased, nor be used as grounds for adding other structures or uses that are now prohibited in the same zone. This Article provides standards by which minor nonconforming uses can be made "conforming" through a public hearing process.

- (c) **Reduction of Nonconformities.** It is the policy of the City to encourage reinvestments in property that increase its value and utility and reduce its external impacts. Since bringing a developed parcel into full compliance with this UDC may involve substantial costs that may discourage reinvestment, Division 7-4, *Other Physical Nonconformities*, provides a set of thresholds for determining when new construction or modifications to development trigger a requirement for increasing conformity with the various requirements of this UDC.

Sec. 21-7-204. - Conversion of a Nonconforming Use to a Conforming Use

- (a) **Generally.** In many instances, nonconforming uses may be integral parts of the City's fabric, that is, its character and function, so their continuing existence promotes the City's policy of retaining existing businesses or protecting its character and neighborhoods. In these instances, the classification "nonconforming use" and resulting restriction on investment may not be what the community desires. As such, a nonconforming use may be made "conforming" pursuant to this Section in order to remove the potential stigma associated with the "nonconforming" designation.
- (b) **Limitation.** Unlawful uses may not be made conforming under this Section.
- (c) **Conversion by Conditional Use Approval; Standards.** A conditional use approval may be granted to make a nonconforming use "conforming," if:
- (1) The criteria for approval of a conditional use set forth in Section 21-2-302, *General Standards for All Conditional Uses*, are met; and
 - (2) The use has minimal nonconformities and has been integrated into the function of its surrounding neighborhood or zone, as evidenced by the following:
 - a. Nearby City residents regularly patronize the use or are employed by the use (for nonresidential uses in or abutting residential neighborhoods).
 - b. Management practices eliminate nuisances such as:
 - i. Spillover of noise or light;
 - ii. Odors and appearance of waste materials and litter;
 - iii. Unreasonably congested on-street parking; or
 - iv. Comparable conflicts with abutting and nearby properties.
 - c. There is no material history of complaints about the use (a history of complaints is justification for denying the conditional use permit, unless the conditions of the permit will eliminate the sources of the complaints).
 - d. If the use is nonresidential, it is licensed in accordance with the applicable ordinances of the City.
 - e. The use has been maintained in good condition and its classification as a nonconforming use would be a disincentive for such maintenance.
- (d) **Conditions.** Conditions may be imposed relative to bufferyards, landscaping, or other site design provisions, or other limitations (including limitations on future expansion or

operational characteristics) necessary to ensure that, as a conforming use, the use will not become a nuisance. Such conditions may relate to the lot, buildings, structures, lighting, landscaping, parking, drainage, or operations of the use.

- (e) **Effect of Approval.** Uses that comply with the terms of a conditional use approval that is issued in accordance with this Section are converted from “legally nonconforming uses” to “conforming uses” by virtue of the issuance of the conditional use permit, and subject to its terms. Conditional use approvals shall be provided to the Applicant in writing and may be recorded by the Applicant at the Applicant’s expense.
- (f) **Effect of Denial.** If an application for conversion of a nonconforming use is denied, the use may thereafter continue as a nonconforming use.

Sec. 21-2-302. - General Standards for All Conditional Uses

- (a) **Generally.** All conditional uses shall meet the standards of this Section related to plan implementation, compatibility, and community need.
- (b) **Plan Implementation.** The proposed conditional use in its proposed location will not conflict with the implementation of current adopted plans of the City, including, but not limited to, the Comprehensive Plan;
- (c) **Compatibility.** The conditional use:
 - (1) Will be compatible with surrounding land uses;
 - (2) Is proposed for a location that is appropriate in terms of mitigating the impacts or risks of the use to the natural environment, or the environmental impacts or risks are mitigated through the design or the operation of the use; and
 - (3) Will not materially detract from the character of the immediate area or negatively affect the anticipated development or redevelopment trajectory (for example, by creating a critical mass of similar conditional uses that is likely to discourage permitted uses by making the vicinity less desirable for them).
- (d) **Community Need.** The conditional use, in the proposed location, will:
 - (1) Address a material need for the use in the community; or
 - (2) Create jobs that are likely to pay more than the median wages for the region, or support a critical mass of related and mutually supportive land uses that promote economic development and opportunity.

Article XI. - Measurements, Calculations, Rules of Construction, Acronyms, and Definitions

Division 11-1. - Measurements and Calculations

Sec. 21-11-101. - Measurements.

- (b) **Building coverage.** Building coverage is measured as the area of a lot or parcel that is occupied by principal and accessory buildings at ground level. For the purpose of this UDC, building coverage is measured as the footprint of the principal and any accessory buildings at grade, including any carport (whether enclosed or not). Eaves, overhangs, and decks that project less than two feet from the building walls are not included in the measurement of building coverage. Overhangs, covered porches, cantilevers, and decks that project more than two feet from building walls are included in the measurement of building coverage.

Sec. 21-7-204. - Conversion of a nonconforming use to a conforming use.

- (a) *Generally.* In many instances, nonconforming uses may be integral parts of the city's fabric, that is, its character and function, so their continuing existence promotes the city's policy of retaining existing businesses or protecting its character and neighborhoods. In these instances, the classification "nonconforming use" and resulting restriction on investment may not be what the community desires. As such, a nonconforming use may be made "conforming" pursuant to this Section in order to remove the potential stigma associated with the "nonconforming" designation.
- (b) *Limitation.* Unlawful uses may not be made conforming under this section.
- (c) *Conversion by conditional use approval; standards.* A conditional use approval may be granted to make a nonconforming use "conforming," if:
 - (1) The criteria for approval of a conditional use set forth in section 21-2-302, are met; and
 - (2) The use has minimal nonconformities and has been integrated into the function of its surrounding neighborhood or zone, as evidenced by the following:
 - a. Nearby city residents regularly patronize the use or are employed by the use (for nonresidential uses in or abutting residential neighborhoods).
 - b. Management practices eliminate nuisances such as:
 - 1. Spillover of noise or light;
 - 2. Odors and appearance of waste materials and litter;
 - 3. Unreasonably congested on-street parking; or
 - 4. Comparable conflicts with abutting and nearby properties.
 - c. There is no material history of complaints about the use (a history of complaints is justification for denying the conditional use permit, unless the conditions of the permit will eliminate the sources of the complaints).
 - d. If the use is nonresidential, it is licensed in accordance with the applicable ordinances of the city.
 - e. The use has been maintained in good condition and its classification as a nonconforming use would be a disincentive for such maintenance.
- (d) *Conditions.* Conditions may be imposed relative to bufferyards, landscaping, or other site design provisions, or other limitations (including limitations on future expansion or operational characteristics) necessary to ensure that, as a conforming use, the use will not become a nuisance. Such conditions may relate to the lot, buildings, structures, lighting, landscaping, parking, drainage, or operations of the use.
- (e) *Effect of approval.* Uses that comply with the terms of a conditional use approval that is issued in accordance with this section are converted from "legally nonconforming uses" to "conforming uses" by virtue of the issuance of the conditional use permit, and subject to its

terms. Conditional use approvals shall be provided to the applicant in writing and may be recorded by the applicant at the applicant's expense.

- (f) *Effect of denial.* If an application for conversion of a nonconforming use is denied, the use may thereafter continue as a nonconforming use.

Sec. 21-2-302. - General standards for all conditional uses.

- (a) *Generally.* All conditional uses shall meet the standards of this section related to plan implementation, compatibility, and community need.
- (b) *Plan implementation.* The proposed conditional use in its proposed location will not conflict with the implementation of current adopted plans of the city, including, but not limited to, the comprehensive plan;
- (c) *Compatibility.* The conditional use:
 - (1) Will be compatible with surrounding land uses;
 - (2) Is proposed for a location that is appropriate in terms of mitigating the impacts or risks of the use to the natural environment, or the environmental impacts or risks are mitigated through the design or the operation of the use; and
 - (3) Will not materially detract from the character of the immediate area or negatively affect the anticipated development or redevelopment trajectory (for example, by creating a critical mass of similar conditional uses that is likely to discourage permitted uses by making the vicinity less desirable for them).
- (d) *Community need.* The conditional use, in the proposed location, will:
 - (1) Address a material need for the use in the community; or
 - (2) Create jobs that are likely to pay more than the median wages for the region, or support a critical mass of related and mutually supportive land uses that promote economic development and opportunity.

The regular meeting of the Planning Commission was called to order on the above date at 6:02 p.m. by Christopher Lopez. Present were the following members: Darrel Cooper, David Mize, Christopher Lopez and Kindra Lambert. Excused was: Mark Manzanarez. A quorum was declared. Staff present: Deacon Aspinwall, Harry Reynolds, Sylvia Vigil and Nicole Valdez.

Agenda Approval: M/S/C. Mize, Cooper. Motion was made to approve the agenda as presented. All approved, none opposed.

Approval of the Minutes: M/S/C. Mize, Cooper. Motion made to approve the minutes of the June 26, 2019 meeting as presented. All approved, none opposed.

Aspinwall reads Staff Recommendation for Car Wash.

Lopez: To the individuals that submitted the application, please come forward to testify.

Kathy Rogers Woods, I am new to the City of Alamosa as the Economic Developer. This is one of the first projects that we have worked on so while it's not new business, this is an existing business that has been here since forever. It is kind of older in its function and look. Although now the City Code requires that there not be a carwash within the Central Business District, it would have been grandfathered in and there have not been improvements made to it, these improvements will approve everything about it. The look, the feel and the actual functions. So we are coming to you today to request your consideration on allowing this to move forward. It will be beautified and they will explain further what kind of interworkings will be taking place. It

has been acting as a carwash for a long time but the improvements will be nice for the city and downtown so I am going to turn it over to Jeremy De Herrera who is the person who is making it happen.

Lopez: Thank you, please state your name and address for the record.

De Herrera: Hello, my name is Jeremy De Herrera, 12750 County Rd. 109 S. Alamosa, CO 81101. First of all I would like to thank everyone for their time. I just want to give an over view as far as what I am doing as far as the lot and the building goes. I do have a few people from Advanced Auto Solutions here with me who will be doing the equipment in there so they will be able to answer questions as far as that goes.

My name is Gregory Mc Caden, my address is 14110 West 63rd Arvada, CO
My name is Will Klum, 6431 S. Dallas Ct. Englewood, CO

Deherrera: One of the big things that I wanted to do was improve the esthetics of that area when I started considering opening up a car wash. We will be doing some building upgrades to it and some of the upgrades that we will be doing would be putting in a tunnel in there which will be 40 foot and it will be the bay that is furthest to the West. Right now it's a 5 bay wash. I will be a touchless automatic, meaning that nothing will touch your vehicle besides that water and the chemical. With that process we will go through and update the buildings features. We will put stucco into it, we are also going to re do the roof skirt that goes on the top of it. We are also going to approve the insides of the bays and the vinyl panel. We will be bringing in LED lighting which I think will help improve the darkness of that area. When you pass by the area late at night it seems to be somewhere that you would not like to hang out very long. There will be a security system, new lighting, light poles out in the back and hopefully make it as welcoming as we possibly can. We also have plans to take out the concrete in the area and replace it with level concrete so we will be taking out the grade. We will be doing heated concrete and taking it all the way to Main street and redoing the sidewalk in that area. So that is what we have in mind for the building. I will let these guys speak about the equipment so that you will have an understanding of what will be going on as far as that goes. My big push for this was to try and keep everything as local as I can. They are all local contractors coming in. The only ones that we could not keep local are the car wash guys only because we don't have that service in Alamosa. I am hoping that this brings a lot of people to downtown. I am very open to the idea of having fundraisers and community events held there. Just a good place to bring people and get them into the downtown area as well.

Lopez: What are the hours of operation that is being planned?

De Herrera: Right now it will be 24 hours per day, 7 days per week. Everything is ran with little labor besides myself and maybe a couple part timers to keep the lot clean.

Lopez: Do we have any other questions for Mr. De Herrera before we hear from his partners?

Mc Cadin: I have been in the car wash business for roughly 30 years. Our goal is to take an existing business and let it come back to life, upgrade the equipment needs. We will go to more energy efficient services that are required today and bring that up to standard in addition to

adding an automatic wash to one of the bays. It is efficient with water use, time, typical wash cycles are quicker. We will also offer multiple ways to pay for the wash, cash, credit card, club wash programs etc. So really that in a nut shell is what we are trying to get Jeremy to do.

Lopez: Can you talk a little bit about car washes that you are ahead of in the metro area etc.?

Mc Cadin: Sure! Right now we maintain work under about 60 individual car washes. We personally don't own any car washes, our business is to just support them, put them together, and give the owners a good business model so they can grow on it.

Lopez: Is there any additional signage to the car wash that is planned?

Mc Cadin: The signage is mainly just informational signage, instructions on how to use the car wash, things like that.

Lopez: Jeremy, for the car wash itself, are you going for resign age at all?

De Herrera: It will be "Waterworks Car Wash" it is already a formed entity. I have already done that through an LLC.

Lopez: Just for staff record. Kathy Rogers has provided us a site plan so that we can look at. Thank you.

Rogers: I just want to say that the Bobisky family has been on that block since 1945 or something like that so it has been a long time. They started a car wash in hopes to someday retire in hopes to sell that car wash and I think that is part of it for me, it would be a shame if at some point some developer came in and was going to raise that car wash and have something else built. It's an opportunity. The place has been for sale for 8 years. Jeremy will have signage that directs people from the alley to the engrese. And then he will have signage appropriate to watch for pedestrian's in the exit.

Lopez: Is there any signage for 6th Street as you go east out of Alamosa?

Rogers: We need to think about that but no not at this moment.

Mize: So as designed, the entrance will be off the alley and exit out onto Main Street?

De Herrera: Yes that is correct. And we will have directional signs above the bays and such to direct people as well.

We have been in business 13 years now as Advanced Car Wash Solutions, and I have been in the business for 35 years myself.

Lopez: Is there any concerns or thought when you think of winter time? When you come out of the bay to Main Street the ice and snow that can accumulate on that asphalt there. Is there any solutions or thoughts about that?

Mc Cadin: Yes, there will be heated pads all the way out of the automatic bay and the self-serve bays.

Lopez: Any other questions at this point?

Is there anyone that opposes this request?

Lopez: Is there any engineering considered for the traffic that is coming though from City Hall into the car wash?

Reynolds: No there is not any engineering on that at this time. This is why they did the controlled striping. Without being restrictive to the other businesses there is nothing in the works at this time.

Approval of Water Works Carwash (Valley Car Wash) Conversion from Non-conforming to Conforming Use and Subsequent Required Conditional Use with Staff Recommendations:
M/S/C. Mize, Cooper. All approved, none opposed.

Alfirio (Armando) Martinez Residential Use from Non-conforming to Conforming Use and Subsequent required Conditional Use.

Aspinwall reads the staff report.

Applicant at podium.

Lopez: Please state your name and address for the record.

Marisa Rodriguez, 616 2nd Street, Alfirio (Armando) Martinez, 616 2nd Street

Rodriguez: Based on the staff recommendation and the size of the garage, we are requesting that the Planning Commission approve the original size that we submitted which was the 840 Sq. Feet. I do know that the staff has recommended based on the ratio of the ground coverage. However, several residences as stipulated by the staff are below and above where our percentage would lie. One of our neighbors is at 37% and the other neighbor is at 47% and if we were able to build the garage at the 84 sq. ft. that we are requesting, we would sit right in the middle of that at around 44% so right now that is what we are requesting.

Lopez: Any questions for the applicants?
Does anyone oppose this application?

Mize: Question for staff. The setback would be the same on each plan correct?

Aspinwall: That is correct. The set backs are the same. It is just the building coverage ratio.

Lopez: So should we hold up on this application and wait for the city to move forward on its own bulk zoning map for this particular part of the neighborhood so the city has a plan eventually to look at this whole area and rezone it potentially but they are not at that process yet. So you have a time frame on when you would be looking to do that?

Aspinwall: We would hope to do it by the end of the year. There is really no guarantee. As you know, we are in search for a City Planner at this time, so to answer that, there is not a very good time line at this moment. The Martinez's did come with this request back in May so in just a curtesy of trying to give them some different avenues to approach Planning Commission instead of waiting for the city to change the zoning underneath them.

Lopez: Do you think that Staff recommendation would have been different if you knew that in September you would be looking at the planning process, would staff still want to move forward?
Aspinwall: I believe so. And I think that it is also worth pointing out that previous UDC's did allow for single family dwellings in commercial business.

Reynolds: One of the things that Deacon and Sylvia have been working on quite extensively is they have went through the whole city and they have looked into the transition zones from the commercial zones to the residential areas and a big part of it is that they are looking into area that would be areas that would be a good candidate for this mixed use zone which really helps cater to that transition. So with the work that they have put together I think that they have come up with a good plan. We just need to get a Planner on board to make sure. If this person agrees, then they will have to inforce it in the future.

Lopez: Any other questions from the Planning Commission members?

Public hearing closed at 6:26 p.m.

Mize: I move that we approve the application with the housing plat but allow the exception for them to build at their original proposed size and wave the 4% coverage area.

Approval of Alfirio (Armando) Martinez Residential Use from Non-conforming to Conforming Use and Subsequent Required Conditional Use. M/S/C: Mize, Cooper All approved, none opposed.

Alamosa Solar South CSG LLC, Solar Garden

Aspinwall reads Staff Recommendation. This is a project that has been in the works and in the background for quite some time. The company in question approached the city to see if the city would be willing to lease certain properties for a solar garden. City Council met and chose this specific location as a potential site. Under the UDC, a utility use in an agricultural zone is a conditional use permit and after reviewing the application, it meets all the provisions. So we recommend the approval. The only condition we recommend is that they have a 7 foot fence with some sort of vision screening element. That is what we have seen and what we have applied and that is what the Planning Commission stipulated for the solar farm that is over by the high school and we feel that that should have some adequate safety and minimize any sort of visual impacts from adjacent properties and so on.

Applicant takes the podium.

Lopez: Please state your name and address for the record.

My name Jonathon Moore, 5740 Prospect Rd. Longmont, CO 80503

Moore: Deacon is right. This has been around for a while. Our company was awarded 5 community garden projects in the valley going back a few years, those are dependent upon the availability of sub stations. Have you all had a community garden project in the city before? I don't think so. So we have a program that provides this opportunity for us to build projects. They are limited to two megawatts in size, it's about 12 acres. We are required to sell through

proscription agreements back to customers. Customers get cost savings on their bills that can be municipal, commercial, whatever it might be. 10% of the total projects production is reserved for low income residents. There are various benefits to it. These projects are happening all around Colorado. We are building 2 in Weld County right now. We have one approved and getting ready to break ground at Monte Vista Middle School, we have one approved in Alamosa County, 285 Rd. 12 S. We are hoping this will be one of our additional projects.

The construction part of it takes up to maybe 2 months. Once they are built, they are quiet, they have external lighting on them. There is no noise associated with it, no water and sewer so I would think that they are a pretty benign neighbor over time. They are single access trackers. They pick up the sun. The whole system faces east in the morning, mid-day they will be tabletop like, in the evening they turn west and then at night they come back. So it is the most efficient technology that we are working with right now. About 6 or 8 weeks ago, city council did vote to be a subscriber for this.

The only place where we ask for consideration based on staff recommendation is two things. One is fence height. Originally the electrical code required an 8 foot fence I think. In 2017 the code changed for projects of this size. It is considered 1,000 volts or less. This project meets that and so we are only required to have a 6 foot fence by code so I would ask of your consideration of that. My construction guy is saying that 7 feet is almost worse than 8. It is between sizes. At 7 foot we would basically be cutting down. We would ask you if 6 feet would be sufficient.

The only other place that we are asking for consideration is, we were going back and forth on trying different screening things. I think what we have decided to do is what was done at the high school project. So we are asking if we can do that on the side that is facing the mobile home park and the side facing 20th Street. Those are the sides that are impacted sites perhaps. So we would ask if you would consider those two changes if you would. I think this is consistent with your master plan, your image, your business support, I think that you will be as proud of it as we will be.

Mize: How close to Old Airport Road will this be?

Moore: It is a 36 acre parcel.

(Deacon pulls up site plan on overhead for all to see)

It is about 1000 feet. And we are up to the accepted parcel other than the access point and there will be a space between us and the mobile home park because there is a sewer line that runs out there.

Moore: About 1300 feet east to west, I am just using google earth.

Mize: At the tallest, how tall will these be?

Moore: They are about nine feet.

Lopez: So what I am hearing is that staff recommends a 7 foot fence and the applicant would like a 6 foot fence. Can we get staff to talk a little more about this?

Aspinwall: Some of the rationale was safety primarily. We haven't to my knowledge at least had any issues at that site so it mostly had to do with consistency and safety. I don't have any statistics to say that a 6 foot fence is adequate or not.

Public Hearing closed at 7:07p.m.

Mize: I move that we approve the proposed conditional use with the condition of a 6 foot fence and the visual screening on three sides and not necessarily on the north side. So on the west side (on the 20th St. side) The recommendation would be to make a motion on what the applicant brought in tonight and not what the staff recommends. Just so we are clear.

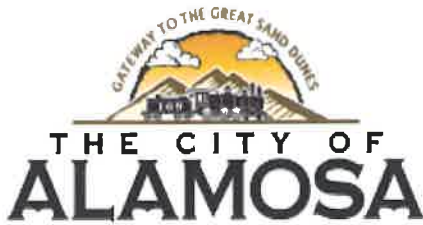

Subject/Title:

Water Works Car Wash (Valley Car Wash) Conversion from Non-conforming to Conforming Use and Conditional Use Permit

Recommended Action:

That Council ratify the unanimous Planning Commission recommendation changing the Water Works Car Wash (Valley Car Wash) from a non-conforming to a conforming use and issue the Conditional Use Permit **with the conditions set by Planning Commission.**

Background:

The existing facility was constructed in 1968 and has historically been a permitted use. Since the downtown overly was enacted in 2008, and continuing with the adoption of the UDC effective January 1, 2018, the use has been non-conforming, but grandfathered in. No improvements have been completed since, and the site has subsequently experienced deterioration. Its classification as a nonconforming use is a disincentive for maintenance. Converting it to a conforming use on conditions set forth in this recommendation will enhance the aesthetic of the CBD.

The property was recently purchased and the property owner intends to clean up the area and to host community events such as fundraisers and fleet discounts. Additionally, he anticipates adding a automated section to the property. It is believed a car wash at the east gateway of the City, equipped with state-of-the-art features, will be a good addition to the CBD and bring people downtown.

The UDC allows non-conforming uses to be converted to conforming uses. This process is found at Sec. 21-7-204. - Conversion of a nonconforming use to a conforming use -- which provides as follows:

(a) Generally. In many instances, nonconforming uses may be integral parts of the city's fabric, that is, its character and function, so their continuing existence promotes the city's policy of retaining existing businesses or protecting its character and neighborhoods. In these instances, the classification "nonconforming use" and resulting restriction on investment may not be what the community desires. As such, a nonconforming use may be made "conforming" pursuant to this Section in order to remove the potential stigma associated with the "nonconforming" designation.

The UDC requires certain aspects be taken into consideration to be eligible for a change from a non-conforming to a conforming use and staff has indicated that this request meets those aspects and the Planning Commission unanimously agreed, so long as the conditions they suggested are imposed. The conversion must meet the standards set forth in Sec. 21-7-204 and also those for a conditional use set forth in Sec. 21-2-302. Both sections are attached for your reference.

Planning Commission's unanimous vote did come with two conditions:

- 1) Per the proposed ingress-egress plan, *DO NOT ENTER* signs be installed along Main Street.
- 2) Planters or other beautification measures be taken to make the pedestrian corridor along Main Street more visually appealing, thereby improving the character of the Central Business District.

Issue Before the Council:

Does Council wish to ratify the unanimous decision of the Planning Commission to approve the requested Conversion from Non-conforming to Conforming Use and approve the Conditional Use Permit as presented?

Alternatives:

- Council may choose to ratify the requested Conversion from Non-conforming to Conforming Use and approve the Conditional Use Permit as presented.
- Council may choose to place the issue for public hearing on the next Council Meeting agenda and approve, amend, or deny the Conditional Use Permit after conducting the public hearing.

Conclusion:

Until such time as the main business corridor has little or no vacant commercial properties, it is suggested that occupying and revitalizing existing, non-conforming business is in the best interest of the community.

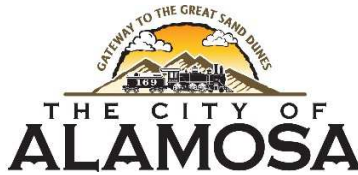


VICINITY PLAN

BACKGROUND

The subject property (Valley Car Wash) is located at 418 Main Street due west of Calvillo's Restaurant, otherwise known as lots 7 thru 9 & W 18'9" of lot 10 & E 6'3" of lot 10 & all lot 11. The site is currently improved with existing carwash bays and is within the Central Business District (CBD) zone.

The existing facility was constructed in 1968 and has historically been a permitted use. Since the downtown overly was enacted in 2008, and continuing with the adoption of the UDC effective January 1, 2018, the use has been non-conforming, but grandfathered in. No improvements have been completed since, and the site has subsequently experienced deterioration. The property has been listed for sale for approximately eight years by the owner, Tom Bobicki. Currently the property is under contract to be sold to Jeremy De Herrera when awareness about the non-conforming status came up.

Mr. De Herrera is contracted with a firm called Advance Carwash Solutions. They install new equipment and improvements to the property including all new façade features, concrete, LED lighting, automatic car washes, electronic pay stations, as well as a cell phone application and rewards system.

A motor vehicle wash is currently not permitted within the CBD (*cf.* **Table 21-2-204A**). Unless the use is made a conforming use pursuant to Section 21-7-204, no improvements may be made to the property for the grandfathered use.

ANALYSIS AND IMPACT

The completed Land Use Application was delivered to the Public Works Department on 7/29/2019. Per **Sec. 21-7-204**, any non-conforming use may be converted into a conforming use by meeting the approval criteria for a Conditional Use Permit (CUP)- specifically plan implementation, compatibility, and community need. Further requirements state that the non-conforming use should: (a) employ or be regularly patronized by city residents, (b) Have management practices that eliminate nuisances such as: Spillover of noise or light; Odors and appearance of waste

materials and litter; Unreasonably congested on-street parking; or Comparable conflicts with abutting and nearby properties, (c) That there is no material history of complaints about the use, (d) If the use is nonresidential, it is licensed in accordance with the applicable ordinances of the City, and (e) The use has been maintained in good condition and its classification as a nonconforming use would be a disincentive for such maintenance.

Conversations with MIG, the firm contracted for the Downtown Revitalization Plan, offered that reenergizing the existing business is a much better alternative than an additional vacant commercial property in the heart of the City. Further, it should be recognized that its location at the edge of the CBD warrants certain considerations. If the location were more centralized in the CBD, then an argument could be made that it detracts from the character of the surrounding area, but its existing location does not conflict with the surrounding buildings.

CUP Requirements:

Plan Implementation. The proposal would support the Comprehensive Plan's general goal of Business Support and Retention, and more specifically Goal ED.2 – Retain Existing Businesses Across All Sectors And Help Them Adapt And Expand.

Compatibility. The proposal will be compatible with surrounding commercial business uses. The proposal includes measures to mitigate operational runoff into storm sewers, which discharge into the Rio Grande, decreasing the impact to the natural environment. It is not anticipated that the proposed change would detract from the character of the immediate area or negatively affect the anticipated development or redevelopment; the improvement of the site would increase the visual aesthetics of the Central Business District.

Community Need. The proposal supports a critical mass of related and mutually supportive land uses that promote economic development and opportunity. Until such time as the CBD has little or no vacant commercial properties, the proposed conversion should not pose any undue burden on potential development.

Additional Conversion Requirements

- a. Satisfies that nearby City residents regularly patronize the use, particularly after revitalization.
- b. Satisfies management practices eliminate nuisances such as:
 - i. Spillover of noise or light; if approved, the owner will install LED lights with appropriate shielding. The added lighting is intended to discourage loitering at night.
 - ii. Odors and appearance of waste materials and litter; if approved, the site will have increased upkeep.
 - iii. Unreasonably congested on-street parking; will have on-site parking. Additional traffic in the alleyway is anticipated, but not in an unreasonable way.
 - iv. Comparable conflicts with abutting and nearby properties; believed to be no change.

- c. There is no material history of complaints about the use.
- d. The property currently has all appropriate licenses.
- e. The use has not been maintained in good condition; however its classification as a nonconforming use would be a disincentive for such maintenance. Converting it to a conforming use on conditions set forth in this recommendation will enhance the aesthetic of the CBD.

RECOMMENDATION

Planning Commission must decide how it wishes to apply the Unified Development Code. Is it more desirable to be accommodating and permissive with the Code in order to achieve development ends set out, among other places, in the Comprehensive Plan, or is it the vision of Planning Commission to be more restrictive and apply the Code in a more limiting fashion? Will converting a non-conforming use into a conforming use open a floodgate of similar requests, and are the limiting provisions of Section 21-7-204 sufficient to provide guidance in the event of a flood of similar requests? Alternatively, will exceptions be made only for businesses in certain areas/zones? Or single family dwellings currently located in CB zones? On the other hand, is it more beneficial for the promotion of public health, safety, comfort, convenience, prosperity, and general welfare to transition this property to a conforming use? Does Planning Commission wish to retain an existing business and avoid another vacant use in the CBD? Is that what is envisioned in Section 21-7-204?

It is the recommendation of staff that the application be **granted** on the grounds that it enhances the CBD by revitalizing an existing property despite its nonconforming use, and that its enhancement is more beneficial to the vision and direction of the community, as set forth in the Comprehensive Plan and other places, than a restrictive interpretation of the Code would allow for [ref. **Section 21-7-101(c)**, **Section 21-7-204(a)**]; it is also acknowledged that the business has been existing for fifty years- well before the adoption of the current Code- and was a permitted use at that time. It satisfactorily meets the requirements laid out in **Sec. 21-7-204**.

These improvements will enhance the neighborhood. The project owner intends to clean up the area and to host community events such as fundraisers and fleet discounts. It is believed a car wash at the east gateway of the City, equipped with state-of-the-art features, will be a good addition to the CBD and bring people downtown. Until such time as the main business corridor has little or no vacant commercial properties, it is suggested that occupying and revitalizing existing, non-conforming business is in the best interest of the community.

If Planning Commission chooses to recommend approval of the application, staff suggests the following conditions:

- 1) Per the proposed ingress-egress plan, *DO NOT ENTER* signs be installed along Main Street.
- 2) Planters or other beautification measures be taken to make the pedestrian corridor along Main Street more visually appealing, thereby improving the character of the Central Business District [see **Section 21-7-204(d)**], with the conditional use permit containing specific identification of the measures to be taken.

Relevant Code Provisions:

Sec. 21-1-203. - Interpretation

The provisions of this Code may be regarded as the minimum requirements for the promotion of public health, safety, comfort, convenience, prosperity, and general welfare. This Code shall be interpreted to implement its stated purposes, and in such interpretations, the specific shall control the general.

Article VII. - Nonconformities

Sec. 21-7-101. - Purpose

- (a) **Generally.** The application of new regulations to existing development may create circumstances in which existing lot dimensions, density, intensity, land uses, buildings, structures, landscaping and buffering, lighting, parking areas, or signs do not strictly conform to the requirements of the new regulations. For existing lots or development (including uses, buildings, structures, and signs) that are “legally nonconforming,” this Article sets out equitable rules for whether, when, and how the regulations of this UDC apply.

- (b) **Conversion of Nonconformities.** Generally, nonconforming uses, buildings, structures, and signs are not allowed to be enlarged, expanded, increased, nor be used as grounds for adding other structures or uses that are now prohibited in the same zone. This Article provides standards by which minor nonconforming uses can be made “conforming” through a public hearing process.
- (c) **Reduction of Nonconformities.** It is the policy of the City to encourage reinvestments in property that increase its value and utility and reduce its external impacts. Since bringing a developed parcel into full compliance with this UDC may involve substantial costs that may discourage reinvestment, Division 7-4, *Other Physical Nonconformities*, provides a set of thresholds for determining when new construction or modifications to development trigger a requirement for increasing conformity with the various requirements of this UDC.

Sec. 21-7-204. - Conversion of a Nonconforming Use to a Conforming Use

- (a) **Generally.** In many instances, nonconforming uses may be integral parts of the City’s fabric, that is, its character and function, so their continuing existence promotes the City’s policy of retaining existing businesses or protecting its character and neighborhoods. In these instances, the classification “nonconforming use” and resulting restriction on investment may not be what the community desires. As such, a nonconforming use may be made “conforming” pursuant to this Section in order to remove the potential stigma associated with the “nonconforming” designation.
- (b) **Limitation.** Unlawful uses may not be made conforming under this Section.
- (c) **Conversion by Conditional Use Approval; Standards.** A conditional use approval may be granted to make a nonconforming use “conforming,” if:
 - (1) The criteria for approval of a conditional use set forth in Section 21-2-302, *General Standards for All Conditional Uses*, are met; and
 - (2) The use has minimal nonconformities and has been integrated into the function of its surrounding neighborhood or zone, as evidenced by the following:
 - a. Nearby City residents regularly patronize the use or are employed by the use (for nonresidential uses in or abutting residential neighborhoods).
 - b. Management practices eliminate nuisances such as:
 - i. Spillover of noise or light;
 - ii. Odors and appearance of waste materials and litter;
 - iii. Unreasonably congested on-street parking; or
 - iv. Comparable conflicts with abutting and nearby properties.
 - c. There is no material history of complaints about the use (a history of complaints is justification for denying the conditional use permit, unless the conditions of the permit will eliminate the sources of the complaints).
 - d. If the use is nonresidential, it is licensed in accordance with the applicable ordinances of the City.

e. The use has been maintained in good condition and its classification as a nonconforming use would be a disincentive for such maintenance.

- (d) **Conditions.** Conditions may be imposed relative to bufferyards, landscaping, or other site design provisions, or other limitations (including limitations on future expansion or operational characteristics) necessary to ensure that, as a conforming use, the use will not become a nuisance. Such conditions may relate to the lot, buildings, structures, lighting, landscaping, parking, drainage, or operations of the use.
- (e) **Effect of Approval.** Uses that comply with the terms of a conditional use approval that is issued in accordance with this Section are converted from “legally nonconforming uses” to “conforming uses” by virtue of the issuance of the conditional use permit, and subject to its terms. Conditional use approvals shall be provided to the Applicant in writing and may be recorded by the Applicant at the Applicant’s expense.
- (f) **Effect of Denial.** If an application for conversion of a nonconforming use is denied, the use may thereafter continue as a nonconforming use.

Sec. 21-2-302. - General Standards for All Conditional Uses

- (a) **Generally.** All conditional uses shall meet the standards of this Section related to plan implementation, compatibility, and community need.
- (b) **Plan Implementation.** The proposed conditional use in its proposed location will not conflict with the implementation of current adopted plans of the City, including, but not limited to, the Comprehensive Plan;
- (c) **Compatibility.** The conditional use:
 - (1) Will be compatible with surrounding land uses;
 - (2) Is proposed for a location that is appropriate in terms of mitigating the impacts or risks of the use to the natural environment, or the environmental impacts or risks are mitigated through the design or the operation of the use; and
 - (3) Will not materially detract from the character of the immediate area or negatively affect the anticipated development or redevelopment trajectory (for example, by creating a critical mass of similar conditional uses that is likely to discourage permitted uses by making the vicinity less desirable for them).
- (d) **Community Need.** The conditional use, in the proposed location, will:
 - (1) Address a material need for the use in the community; or
 - (2) Create jobs that are likely to pay more than the median wages for the region, or support a critical mass of related and mutually supportive land uses that promote economic development and opportunity.

Aspinwall reads Staff Recommendation for Car Wash.

Lopez: To the individuals that submitted the application, please come forward to testify.

Kathy Rogers Woods, I am new to the City of Alamosa as the Economic Developer. This is one of the first projects that we have worked on so while it's not new business, this is an existing business that has been here since forever. It is kind of older in its function and look. Although now the City Code requires that there not be a carwash within the Central Business District, it would have been grandfathered in and there have not been improvements made to it, these improvements will approve everything about it. The look, the feel and the actual functions. So we are coming to you today to request your consideration on allowing this to move forward. It will be beautified and they will explain further what kind of interworkings will be taking place. It

has been acting as a carwash for a long time but the improvements will be nice for the city and downtown so I am going to turn it over to Jeremy De Herrera who is the person who is making it happen.

Lopez: Thank you, please state your name and address for the record.

De Herrera: Hello, my name is Jeremy De Herrera, 12750 County Rd. 109 S. Alamosa, CO 81101. First of all I would like to thank everyone for their time. I just want to give an over view as far as what I am doing as far as the lot and the building goes. I do have a few people from Advanced Auto Solutions here with me who will be doing the equipment in there so they will be able to answer questions as far as that goes.

My name is Gregory Mc Caden, my address is 14110 West 63rd Arvada, CO
My name is Will Klum, 6431 S. Dallas Ct. Englewood, CO

Deherrera: One of the big things that I wanted to do was improve the esthetics of that area when I started considering opening up a car wash. We will be doing some building upgrades to it and some of the upgrades that we will be doing would be putting in a tunnel in there which will be 40 foot and it will be the bay that is furthest to the West. Right now it's a 5 bay wash. I will be a touchless automatic, meaning that nothing will touch your vehicle besides that water and the chemical. With that process we will go through and update the buildings features. We will put stucco into it, we are also going to re do the roof skirt that goes on the top of it. We are also going to approve the insides of the bays and the vinyl panel. We will be bringing in LED lighting which I think will help improve the darkness of that area. When you pass by the area late at night it seems to be somewhere that you would not like to hang out very long. There will be a security system, new lighting, light poles out in the back and hopefully make it as welcoming as we possibly can. We also have plans to take out the concrete in the area and replace it with level concrete so we will be taking out the grade. We will be doing heated concrete and taking it all the way to Main street and redoing the sidewalk in that area. So that is what we have in mind for the building. I will let these guys speak about the equipment so that you will have an understanding of what will be going on as far as that goes. My big push for this was to try and keep everything as local as I can. They are all local contractors coming in. The only ones that we could not keep local are the car wash guys only because we don't have that service in Alamosa. I am hoping that this brings a lot of people to downtown. I am very open to the idea of having fundraisers and community events held there. Just a good place to bring people and get them into the downtown area as well.

Lopez: What are the hours of operation that is being planned?

De Herrera: Right now it will be 24 hours per day, 7 days per week. Everything is ran with little labor besides myself and maybe a couple part timers to keep the lot clean.

Lopez: Do we have any other questions for Mr. De Herrera before we hear from his partners?

Mc Cadin: I have been in the car wash business for roughly 30 years. Our goal is to take an existing business and let it come back to life, upgrade the equipment needs. We will go to more energy efficient services that are required today and bring that up to standard in the addition to

adding an automatic wash to one of the bays. It is efficient with water use, time, typical wash cycles are quicker. We will also offer multiple ways to pay for the wash, cash, credit card, club wash programs etc. So really that in a nut shell is what we are trying to get Jeremy to do.

Lopez: Can you talk a little bit about car washes that you are ahead of in the metro area etc.?

Mc Cadin: Sure! Right now we maintain work under about 60 individual car washes. We personally don't own any car washes, our business is to just support them, put them together, and give the owners a good business model so they can grow on it.

Lopez: Is there any additional signage to the car wash that is planned?

Mc Cadin: The signage is mainly just informational signage, instructions on how to use the car wash, things like that.

Lopez: Jeremy, for the car wash itself, are you going for resign age at all?

De Herrera: It will be "Waterworks Car Wash" it is already a formed entity. I have already done that through an LLC.

Lopez: Just for staff record. Kathy Rogers has provided us a site plan so that we can look at. Thank you.

Rogers: I just want to say that the Bobisky family has been on that block since 1945 or something like that so it has been a long time. They started a car wash in hopes to someday retire in hopes to sell that car wash and I think that is part of it for me, it would be a shame if at some point some developer came in and was going to raise that car wash and have something else built. It's an opportunity. The place has been for sale for 8 years. Jeremy will have signage that directs people from the alley to the engrese. And then he will have signage appropriate to watch for pedestrian's in the exit.

Lopez: Is there any signage for 6th Street as you go east out of Alamosa?

Rogers: We need to think about that but no not at this moment.

Mize: So as designed, the entrance will be off the alley and exit out onto Main Street?

De Herrera: Yes that is correct. And we will have directional signs above the bays and such to direct people as well.

We have been in business 13 years now as Advanced Car Wash Solutions, and I have been in the business for 35 years myself.

Lopez: Is there any concerns or thought when you think of winter time? When you come out of the bay to Main Street the ice and snow that can accumulate on that asphalt there. Is there any solutions or thoughts about that?

Mc Cadin: Yes, there will be heated pads all the way out of the automatic bay and the self-serve bays.

Lopez: Any other questions at this point?

Is there anyone that opposes this request?

Lopez: Is there any engineering considered for the traffic that is coming though from City Hall into the car wash?

Reynolds: No there is not any engineering on that at this time. This is why they did the controlled striping. Without being restrictive to the other businesses there is nothing in the works at this time.

Lopez: Please state your name and address for the record.

Marisa Rodriguez, 616 2nd Street, Alfirio (Armando) Martinez, 616 2nd Street

Rodriguez: Based on the staff recommendation and the size of the garage, we are requesting that the Planning Commission approve the original size that we submitted which was the 840 Sq. Feet. I do know that the staff has recommended based on the ratio of the ground coverage. However, several residences as stipulated by the staff are below and above where our percentage would lie. One of our neighbors is at 37% and the other neighbor is at 47% and if we were able to build the garage at the 84 sq. ft. that we are requesting, we would sit right in the middle of that at around 44% so right now that is what we are requesting.

Lopez: Any questions for the applicants?
Does anyone oppose this application?

Mize: Question for staff. The setback would be the same on each plan correct?

Aspinwall: That is correct. The set backs are the same. It is just the building coverage ratio.

Lopez: So should we hold up on this application and wait for the city to move forward on its own bulk zoning map for this particular part of the neighborhood so the city has a plan eventually to look at this whole area and rezone it potentially but they are not at that process yet. So you have a time frame on when you would be looking to do that?

Aspinwall: We would hope to do it by the end of the year. There is really no guarantee. As you know, we are in search for a City Planner at this time, so to answer that, there is not a very good time line at this moment. The Martinez's did come with this request back in May so in just a curtesy of trying to give them some different avenues to approach Planning Commission instead of waiting for the city to change the zoning underneath them.

Lopez: Do you think that Staff recommendation would have been different if you knew that in September you would be looking at the planning process, would staff still want to move forward?
Aspinwall: I believe so. And I think that it is also worth pointing out that previous UDC's did allow for single family dwellings in commercial business.

Reynolds: One of the things that Deacon and Sylvia have been working on quite extensively is they have went through the whole city and they have looked into the transition zones from the commercial zones to the residential areas and a big part of it is that they are looking into area that would be areas that would be a good candidate for this mixed use zone which really helps cater to that transition. So with the work that they have put together I think that they have come up with a good plan. We just need to get a Planner on board to make sure. If this person agrees, then they will have to inforce it in the future.

Lopez: Any other questions from the Planning Commission members?

Public hearing closed at 6:26 p.m.

Mize: I move that we approve the application with the housing plat but allow the exception for them to build at their original proposed size and wave the 4% coverage area.

Approval of Alfirio (Armando) Martinez Residential Use from Non-conforming to Conforming Use and Subsequent Required Conditional Use. M/S/C: Mize, Cooper All approved, none opposed.

Alamosa Solar South CSG LLC, Solar Garden

Aspinwall reads Staff Recommendation. This is a project that has been in the works and in the background for quite some time. The company in question approached the city to see if the city would be willing to lease certain properties for a solar garden. City Council met and chose this specific location as a potential site. Under the UDC, a utility use in an agricultural zone is a conditional use permit and after reviewing the application, it meets all the provisions. So we recommend the approval. The only condition we recommend is that they have a 7 foot fence with some sort of vision screening element. That is what we have seen and what we have applied and that is what the Planning Commission stipulated for the solar farm that is over by the high school and we feel that that should have some adequate safety and minimize any sort of visual impacts from adjacent properties and so on.

Applicant takes the podium.

Lopez: Please state your name and address for the record.

My name Jonathon Moore, 5740 Prospect Rd. Longmont, CO 80503

Moore: Deacon is right. This has been around for a while. Our company was awarded 5 community garden projects in the valley going back a few years, those are dependent upon the availability of sub stations. Have you all had a community garden project in the city before? I don't think so. So we have a program that provides this opportunity for us to build projects. They are limited to two megawatts in size, it's about 12 acres. We are required to sell through

proscription agreements back to customers. Customers get cost savings on their bills that can be municipal, commercial, whatever it might be. 10% of the total projects production is reserved for low income residents. There are various benefits to it. These projects are happening all around Colorado. We are building 2 in Weld County right now. We have one approved and getting ready to break ground at Monte Vista Middle School, we have one approved in Alamosa County, 285 Rd. 12 S. We are hoping this will be one of our additional projects.

The construction part of it takes up to maybe 2 months. Once they are built, they are quiet, they have external lighting on them. There is no noise associated with it, no water and sewer so I would think that they are a pretty benign neighbor over time. They are single access trackers. They pick up the sun. The whole system faces east in the morning, mid-day they will be tabletop like, in the evening they turn west and then at night they come back. So it is the most efficient technology that we are working with right now. About 6 or 8 weeks ago, city council did vote to be a subscriber for this.

The only place where we ask for consideration based on staff recommendation is two things. One is fence height. Originally the electrical code required an 8 foot fence I think. In 2017 the code changed for projects of this size. It is considered 1,000 volts or less. This project meets that and so we are only required to have a 6 foot fence by code so I would ask of your consideration of that. My construction guy is saying that 7 feet is almost worse than 8. It is between sizes. At 7 foot we would basically be cutting down. We would ask you if 6 feet would be sufficient.

The only other place that we are asking for consideration is, we were going back and forth on trying different screening things. I think what we have decided to do is what was done at the high school project. So we are asking if we can do that on the side that is facing the mobile home park and the side facing 20th Street. Those are the sides that are impacted sites perhaps. So we would ask if you would consider those two changes if you would. I think this is consistent with your master plan, your image, your business support, I think that you will be as proud of it as we will be.

Mize: How close to Old Airport Road will this be?

Moore: It is a 36 acre parcel.

(Deacon pulls up site plan on overhead for all to see)

It is about 1000 feet. And we are up to the accepted parcel other than the access point and there will be a space between us and the mobile home park because there is a sewer line that runs out there.

Moore: About 1300 feet east to west, I am just using google earth.

Mize: At the tallest, how tall will these be?

Moore: They are about nine feet.

Lopez: So what I am hearing is that staff recommends a 7 foot fence and the applicant would like a 6 foot fence. Can we get staff to talk a little more about this?

Aspinwall: Some of the rationale was safety primarily. We haven't to my knowledge at least had any issues at that site so it mostly had to do with consistency and safety. I don't have any statistics to say that a 6 foot fence is adequate or not.

Public Hearing closed at 7:07p.m.

Mize: I move that we approve the proposed conditional use with the condition of a 6 foot fence and the visual screening on three sides and not necessarily on the north side. So on the west side (on the 20th St. side) The recommendation would be to make a motion on what the applicant brought in tonight and not what the staff recommends. Just so we are clear.

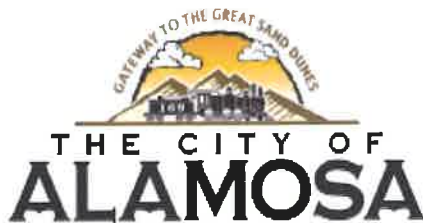

First Reading, Ordinance No. 21-2019, an ordinance approving the annexation of the 2019 Comfort Inn amended petition for the annexation of a tract of land containing approximately 8.01 total acres located in the NE¼ of Section 6, Township 37 north, Range 10 east, New Mexico principal meridian, Alamosa County, Colorado.

Recommended Action:

Approve Ordinance No. 21-2019 on first reading and set for public hearing on September 18, 2019, at 7:00 p.m. or as soon thereafter as the matter may be heard.

Background:

The owners of the Comfort Inn originally filed an application for annexation of the Comfort Inn and the property surrounding it on November 10, 2018. That application sought annexation of only the 3.8 acre parcel on which the hotel is located. The owners then asked that the petition be put on hold while they debated including an additional 4.21 acres adjacent to the hotel parcel, containing a single family dwelling. They filed an amended petition on July 31, 2019, to include both parcels in the Comfort Inn Division of Land, totaling 8.01 acres. Council found that amended petition to be in substantial compliance with C.R.S. § 31-12-107(1) by Resolution No. 16-2019, August 7, 2019.

Pursuant to direction given by Council, and in light of the tax revenue expected to be generated from the hotel (2017 projected tax revenue of \$51,000, 2018 of \$48,000, with 2019 numbers so far trending higher than 2018), staff has worked with the applicant to develop a draft annexation agreement that provides for the City to extend the existing water line from its current terminus within Murphy Theaters Subdivision to the County Road 107 South westerly right-of-way. The draft agreement allows the applicant to continue to use the existing lift station and sewer line currently serving the annexed property, at applicant's sole responsibility and expense, to convey sewage to the existing City main until such time as the applicant chooses to engineer and construct and install to match existing 8-inch sewer line, extending it from its current terminus within the Murphy Theater Subdivision to the County Road 107 South westerly right-of-way, again at Owner's sole expense.

A draft of the annexation agreement is also attached. The annexation agreement is not a subject of this first reading of the ordinance, but is provided merely for background. Comment, if any, is appropriate, but no action will be taken on the agreement until the public hearing and second reading of the ordinance. Plats of Tracts 1 and 2 of the Comfort Inn Division of Land are attached. Staff has requested that applicant consolidate both tracts on a single annexation plat, which should be available for second reading. The public hearing on eligibility will be conducted on the same meeting as the public hearing and second reading for this ordinance at Council's meeting on September 18, 2019.

Issue Before the Council:

Does Council wish to approve Ordinance No. 21-2019?

Alternatives:

(1) Approve the Ordinance on first reading and set for public hearing on September 18, 2019, at 7:00 p.m. or as soon thereafter as the matter may be heard.

- (2) Approve the Ordinance with changes, such as not accepting Tract 2 of the proposed annexation, on which the current single family residence is located (Note that action on the draft annexation agreement is not part of this decision, but discussion is appropriate).
- (3) Decline to approve the Ordinance and give staff further direction.

Fiscal Impact:

Tax revenue from the Comfort Inn is projected to be approximately \$50,000 per year. Cost to the City of extending the water main is estimated to be approximately \$14,750 in materials and \$9,100 in in-kind labor, totaling \$23,850.

Legal Opinion:

City Attorney will be available to discuss any legal issues pertaining to the annexation.

Conclusion:

This ordinance, coupled with the annexation agreement when executed, will complete the annexation of the Comfort Inn.

ORDINANCE NO. 21-2019

AN ORDINANCE APPROVING THE ANNEXATION OF THE 2019 COMFORT INN AMENDED PETITION FOR THE ANNEXATION OF A TRACT OF LAND CONTAINING APPROXIMATELY 8.01 TOTAL ACRES LOCATED IN THE NE¼ OF SECTION 6, TOWNSHIP 37 NORTH, RANGE 10 EAST, NEW MEXICO PRINCIPAL MERIDIAN, ALAMOSA COUNTY, COLORADO.

WHEREAS, the amended petition filed by the owners of 100% of the real property included in an area proposed to be annexed, being generally an approximately 8.01 acre parcel in the NE¼ of Section 8, T37N, R10E, NMPM, on which the Comfort Inn and a single family residence are currently located, excluding public streets and alleys and any land owned by the City of Alamosa, was previously found by the Alamosa City Council to be in substantial compliance with Section C.R.S. § 31-12-107(1) (Resolution No. 16-2019, August 7, 2019); and

WHEREAS, all applicable requirements of the *Code of Ordinances of the City of Alamosa, Colorado*, have been fulfilled; and

WHEREAS, the property is eligible for annexation in accordance with the *Municipal Annexation Act of 1965*, as amended, as found by Resolution No. __, 2019, after duly noticed public hearing; and

WHEREAS, the Alamosa City Council finds it in the best interests of the citizens of Alamosa that the proposed property be annexed, consistent with the terms and conditions of the annexation agreement dated September 18, 2019, hereby approved by the City, with direction to the City Manager to execute the annexation agreement on behalf of the City;

NOW, THEREFORE, BE IT HEREBY ORDAINED by the City Council of the City of Alamosa, Colorado:

Section 1. That the property described in the attached Exhibit A is hereby annexed to the City of Alamosa, Colorado, which property has street addresses of 6301 County Road 107 S applicable to Tract 1 (the Comfort Inn), and 6201 County Road 107 S and 6281 County Road 107 S applicable to Tract 2.

Section 2. The zoning for said property is hereby determined and established to be: "CB" (Commercial Business).

Section 3. That, in annexing said property to the City of Alamosa, Colorado, the City does not assume any obligation respecting the construction of water mains, sewer lines, gas mains, electric service lines, streets, or any other services or utilities in connection with the property hereby annexed except as may be expressly provided

by the ordinances of the City of Alamosa, Colorado, or the annexation agreement dated September 18, 2019, approved herein, and that the owners of such annexed property shall be responsible for the cost of extension of such services and utilities.

Section 4. General Repealer. All acts, orders, ordinances, resolutions, or portions thereof in conflict herewith, are hereby repealed to the extent of such conflict.

Section 5. Recording and Authentication. This ordinance, immediately upon its passage, shall be authenticated by the signatures of the Mayor and City Clerk, recorded in the City Book of Ordinances kept for that purposes, and published according to law.

Section 6. Publication and Effective Date. This ordinance shall take effect ten (10) days after publication following final passage. Publication both before and after final passage shall be by the title of this ordinance, which Council determines constitutes a sufficient summary of the ordinance, together with the statement that the full text of the ordinance is available for public inspection and acquisition on the City's website and in the office of the City Clerk.

Section 7. Declaration of Public Interest. This ordinance is necessary to preserve the peace, health, safety, welfare, and to serve the best interest of the citizens of the City of Alamosa, Colorado.

INTRODUCED, READ AND ORDERED published the 4th day of September, 2019, and a public hearing hereon fixed for the 18th day of September, 2019 at 7:00 p.m., or as soon thereafter as the matter may be heard.

ANNEXATION AGREEMENT

This **ANNEXATION AGREEMENT** ("Agreement"), is made and entered into this 18th day of July, 2019, by and between **THE CITY OF ALAMOSA**, a Colorado Municipal Corporation, ("City") and **SKYLINE HOSPITALITY INC** ("Owners").

WHEREAS, Owner is the owner of the real property described in Exhibit "A" ("property"); and

WHEREAS, Owner proposes the annexation of the Property to the City; and

WHEREAS, The City has determined it to be in the best interest of the public health, safety, and welfare of its citizens to impose certain terms and conditions on the Owner in conjunction with the annexation of the Property to the City; and

WHEREAS, Owner and City have come to an Agreement, with respect to the terms and conditions of the annexation of the Property to the City, all as more fully set forth hereafter.

NOW, THEREFORE, in consideration of the recitals, promises, and covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows;

1. Definitions: As used in this Agreement, unless the context clearly requires otherwise:

"Annexation Ordinance" shall mean Ordinance No. 21-2019, adopted by the City Council of the City of Alamosa pursuant to the pending Amended Petition for Annexation of the property, and in accordance with the Municipal Annexation Act of 1965 (Section 31-12-101, et seq., C.R.S.) officially annexing the Property to the City of Alamosa.

"Applicable City Ordinances" shall mean all ordinances of the City that regulate the development, subdivision and use of the Property, as in effect from time to time. Such ordinances shall include, but shall not be limited to, the City's (i) Uniform Development Code, (ii) Street Standards, (iii) Drainage Ordinance, (iv) Flood Prevention Ordinance, (v) Building, Technical and Construction Codes, (vi) Ordinances and policies concerning annexation/water surcharges, (vii) Ordinances concerning payment of fees, (viii) Ordinances concerning public dedications; and (ix) all other applicable City Ordinances, Resolutions, regulations and policies.

"Owners", SKYLINE HOSPITALITY INC, their successors and assigns, and all other subsequent owners of the Property.

"PIF" shall mean the current City Plant Investment Fee as provided for by the Ordinances or regulations of the City at the time such charges are due and payable to the City as provided in Paragraphs 7 & 8 of this Agreement.

"Property" shall mean that certain real property described on the attached Exhibit "A".

2. DEVELOPMENT.

Upon the annexation to the City, development of the Property shall conform in all respects with

all applicable City Ordinances.

3. PROPOSED USE OF THE PROPERTY.

- 3.1 **Land Use District Designation.** In the event of approval of the Petition for Annexation, upon annexation the Property shall be placed in the Commercial Business (CB) zoning district, but only if after receiving testimony at a public hearing the City Council determines that such zoning classification is justified as the most appropriate zoning classification for the property.
- 3.2 **General Plan of Development.** The City and Owner agree that the Property is presently developed, and that any current and future development will be in accordance with applicable City Ordinances. A general development plan for the Property is shown within Exhibit "B".
- 3.3 **Annexation not Contingent.** Owner understands and acknowledges that the annexation of the Property is not contingent upon approval by the City of any particular plan of development of the Property, nor specific zoning classification and development plan, or zoning as may hereafter be approved by City. Owner assumes all risks of obtaining required subdivision and development permits for the Property in accordance with Applicable City Ordinances.

4. UTILITY SERVICE AND PUBLIC IMPROVEMENTS.

- 4.1 **Extensions of Utility Services and Public Improvements.** Except as specifically set forth otherwise in Exhibit C, Owner shall pay all costs for design and construction of all public improvements and utility services necessary to serve the Property, including but not limited to, roads, curbs, gutters, sanitary and drainage sewers, water, street lights, electricity, telephone, gas, and cable television service all in accordance with applicable City or public utility company standards and specifications. Owner specifically agrees to construct or cause to be constructed those extensions and improvements described in Exhibit "C". Owner shall dedicate to the City and applicable public utility companies without charge, free and clear of all liens and encumbrances those easements and rights of way necessary for installation and maintenance of said utility lines and other public improvements including public streets and trails, and in addition shall convey the public improvements to the appropriate entity upon completion and acceptance of the improvements (Exhibit "D"). Evidence of the status of title ownership shall be provided by Owner insuring title in City, by an ALTA insurer acceptable to City, in an amount designated by the Public Works Director, which amount shall be reasonably calculated to cover the actual value to City after the improvements are completed. Such insurance shall be preceded by a title insurance commitment adequate to establish that the Owner can perform this provision.

- 5. PUBLIC DEDICATIONS.** In addition to those dedications required in Paragraph 4 of this Agreement, Owner further agrees to dedicate to the City without charge and free and clear of any liens and encumbrances that certain real property which is described in Exhibit "D". Such dedicated property shall be insured in City, at the expense of Owner, in the manner and amount as is provided in the preceding paragraph regarding Utility Services and Public Improvements.

6. **WATER AND DITCH RIGHTS.** Owner shall retain ownership of its existing well and associated water rights on Tract 2. Owner shall pay cash in-lieu of water rights upon annexation and prior to being connected to City water service in accordance with the Attached Exhibit E for all development currently existing, and prior to connection of any future development at such rate as is applicable at the time of application for such future development (currently \$1,900 per acre foot of water demand).
7. **WATER CHARGES.**
 - 7.1 **Payment of PIF's.** Prior to making connections to the City water utility system, Owner shall pay to the City the PIF for the portion of the Property which is being connected. If the portion of the property being connected is not owned by the present Owner at the time of the connection, the PIF shall be paid by the then-current owner.
 - 7.2 **Water Rates.** Water users on the Property shall pay the then-current rates for water service paid by in-City users, subject to all decreases or increases in fees adopted in accordance with City ordinances and regulations. Water users on the property are subject to all rules, regulations and ordinances pertaining to the City's water system, including all future amendments.
8. **SEWER CHARGES**
 - 8.1 **Payment of PIF's.** Prior to making connections to the City sewer utility system, Owner shall pay to the City the PIF for the portion of the Property which is being connected. If the portion of the Property being connected is not owned by the present Owner at the time of the connection, the PIF shall be paid by the then-current owner.
 - 8.2 **Sewer Rates.** Sewer users on the Property shall pay the then-current rates for sewer service paid by in-City users, subject to all decreases or increases in fees adopted in accordance with City ordinances and regulations. Sewer system users on the property are subject to all rules, regulations and ordinances pertaining to the City's sewer system, including all future amendments.
9. **VESTED PROPERTY RIGHTS.** The Owner hereby waives any and all vested property rights that may exist on the property. Further, nothing contained herein shall be construed as to constitute vesting of development rights.
10. **MISCELLANEOUS.**
 - 10.1 **Effective Date.** This agreement is contingent upon the City approval of the annexation and shall become effective, as of the date on and the time when the annexation itself becomes effective.
 - 10.2 **Parties' Authority.** The City and Owner represent that each has the authority to enter into this Agreement according to applicable Colorado law and the City's Home Rule Charter and Ordinance, and each represents that the terms and conditions hereof are

not in violation of any agreement previously entered into by the City. This Agreement shall not become effective until resolution or other necessary authorizations for the execution of the Agreement are effective.

- 10.3 **Recording.** This Agreement may be recorded in the Alamosa County Clerk and Recorder's Office in order to put prospective purchasers or other interested parties on notice as to the terms and conditions contained herein and liens hereby created.
- 10.4 **Entire Agreement.** This Agreement and the exhibits hereto represent the entire understanding between the parties, and no other agreement concerning this Property, oral or written, made prior to the date of this Agreement, which conflicts with the terms of this Agreement, shall be valid as between the parties.
- 10.5 **Disconnection.** In the event of disconnection of the Property for any reason, the City's infrastructure and service obligations shall be void and of no further force and effect, but all dedications and conveyances to the City made hereunder shall continue in full force and effect unless vacated in the manner provided by law.
- 10.6 **Modification.** This Agreement shall not be modified except in writing executed by all parties hereto.
- 10.7 **Damages and Additional Remedies.** If at any time any part hereof has been breached by the Owners, the City may in addition to other remedies, withhold approval of any or all building or other permits applied for by the Owner on its Property, or withhold issuance of certificates of occupancy until the breach or breaches has or have been cured. Except as otherwise specifically provided for herein, neither party shall be entitled to claim or receive any form of monetary damages, including but not limited to remedial, compensatory, punitive or consequential damages, including economic damages and lost profits.
- 10.8 **Binding Effect.** The agreements and covenants as set forth herein shall be binding upon the Owners, their heirs, successors, and assigns, and all persons who may hereafter acquire an interest in the Property, or any part hereof.
- 10.9 **Joint and Several Liability.** If there are two or more Owners, the responsibility of the Owners shall be joint and several.
- 10.10 **Severability.** In case one or more of the provisions contained in this Agreement shall be invalid, illegal or unenforceable in any respect, the validity, legality and enforceability of the remaining provisions of this Agreement shall not in any way be affected or impaired thereby; provided, however, that if such invalid provision deprives either party of a material benefit to be derived from this prospective annexation, the parties acknowledge that such shall constitute irreparable injury, and entitle such party to relief in equity in the event a satisfactory adaptation of this agreement cannot be reached by the parties.
- 10.11 **Incorporation of Exhibits.** Exhibits "A" through "E" inclusive, which are attached hereto, are incorporated herein by reference.

- 10.12 **Notices.** Any notices required or permitted hereunder shall be sufficient if personally delivered or if sent by certified mail, return receipt requested, addressed as follows:

Notices mailed in accordance with the provisions of this Paragraph shall be deemed to have been given on the 3rd day following mailing. Notices personally delivered shall be deemed to have been given upon delivery. Nothing herein shall prohibit the giving of notice in the manner provided for in the Colorado Rules of Civil Procedure for service of civil process.

- 10.13 **Waiver.** The failure of either party to exercise any of its rights under this Agreement shall not be a waiver of those rights. A party waives only those rights specified in writing and signed by either party waiving such rights.
- 10.14 **Applicable Law.** This Agreement shall be interpreted in all respects in accordance with the laws of the State of Colorado.
- 10.15 **Counterparts.** This Agreement may be executed in several counterparts and/or signature pages and all counterparts and signature pages so executed shall constitute one agreement binding on all parties hereto, notwithstanding that if the parties are not signatories to the original or the same counterpart or signature page.
- 10.16 **Terminology.** Wherever applicable, the pronouns in this Agreement designating the masculine or neuter shall equally apply to the feminine, neuter and masculine genders. Furthermore, wherever applicable within this Agreement, the singular shall include the plural, and the plural shall include the singular.

EXHIBIT "A"

COMFORT INN ANNEXATION

Tracts 1 and 2, Comfort Inn Division of Land, as shown on the plat recorded under Reception No. 373604 as recorded June 19, 2019, in the office of the Alamosa County Clerk and Recorder, located in the Northeast Quarter (NE¼) of Section 6, Township 37 North, Range 10 East of the New Mexico Principal Meridian, Alamosa County, Colorado, containing 8.01 acres, more or less.

EXHIBIT "B"

General Plan of Development

A vicinity map is attached, illustrating the boundary and surrounding area of the property. The anticipated annexation, if approved, encompasses the area demonstrated in said vicinity map.

EXHIBIT "C"

Public Improvements

The City agrees to extend the existing water line from its current terminus within Murphy Theaters Subdivision to the County Road 107 South westerly right-of-way. City agrees to allow Owner to continue to use the existing lift station and sewer line currently serving the annexed property, at Owner's sole responsibility and expense for operation, maintenance and repair, to convey sewage to the existing City main until such time as Owner chooses to engineer and construct and install to match existing 8-inch sewer line, extending it from its current terminus within the Murphy Theater Subdivision to the County Road 107 South westerly right-of-way, again at Owner's sole expense. Owner will be responsible for utility tie-ins from the main lines to the structure. Stamped engineered drawings must be approved by Public Works Director.

For the purposes of pedestrian accessibility and connectivity, the Owner shall be responsible for the installation of sidewalks along the southern and eastern boundary of the subject property and curb and gutter along the eastern boundary at the City's discretion. Construction shall be triggered when sufficient development has occurred to adjacent properties to warrant pedestrian connectivity.

EXHIBIT "D"

Public Dedications

The only public dedications required are utility easements, as shown on the annexation plat.

EXHIBIT "E"

Ditch and Water Rights Dedication

Owner shall pay cash-in-lieu of water rights in the amount of \$1,900 per acre foot multiplied by the amount of water deemed necessary for the development (total water demand, not consumptive use). The amount of such estimated water demand has been determined by applying the assumptions delineated below to existing development on the subject property (the Comfort Inn). In the event the use of the annexed property is increased in the future, such as by addition to the hotel, additional cash-in-lieu payments shall be required, and shall be based upon both the additional uses, and the then-current cash-in-lieu rates applicable to annexations generally.

- a. *Hotel or motel unit: An average of 2.25 patrons/unit times 50 gallons/day/patron.
Comfort Inn = 68 units, usage = 2,792,250 gal = 8.569 acre feet per year.*
- b. *Comfort Inn swimming pool = 10,000 gallons = 0.03acre feet per year*

Total estimated water demand = 8.599acre feet per year. Total cash in lieu payment = \$16,338.00.

At the current time there is negligible landscaping irrigation attributable to the annexed property. Should Owner install landscaping in the future, the parties shall agree upon a reasonable estimate of the area or areas to be irrigated as a result of such new landscaping.

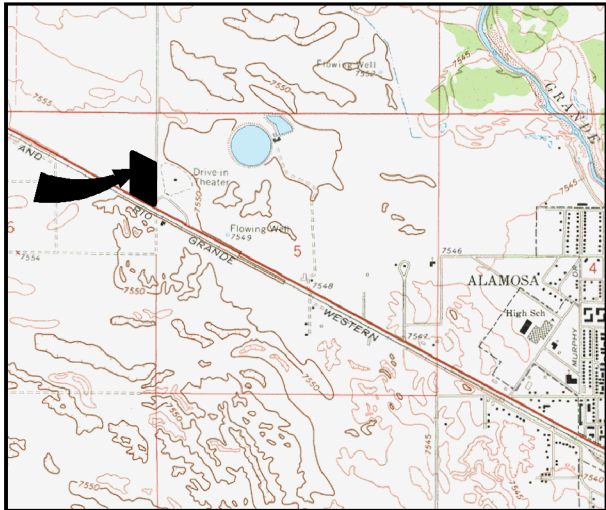
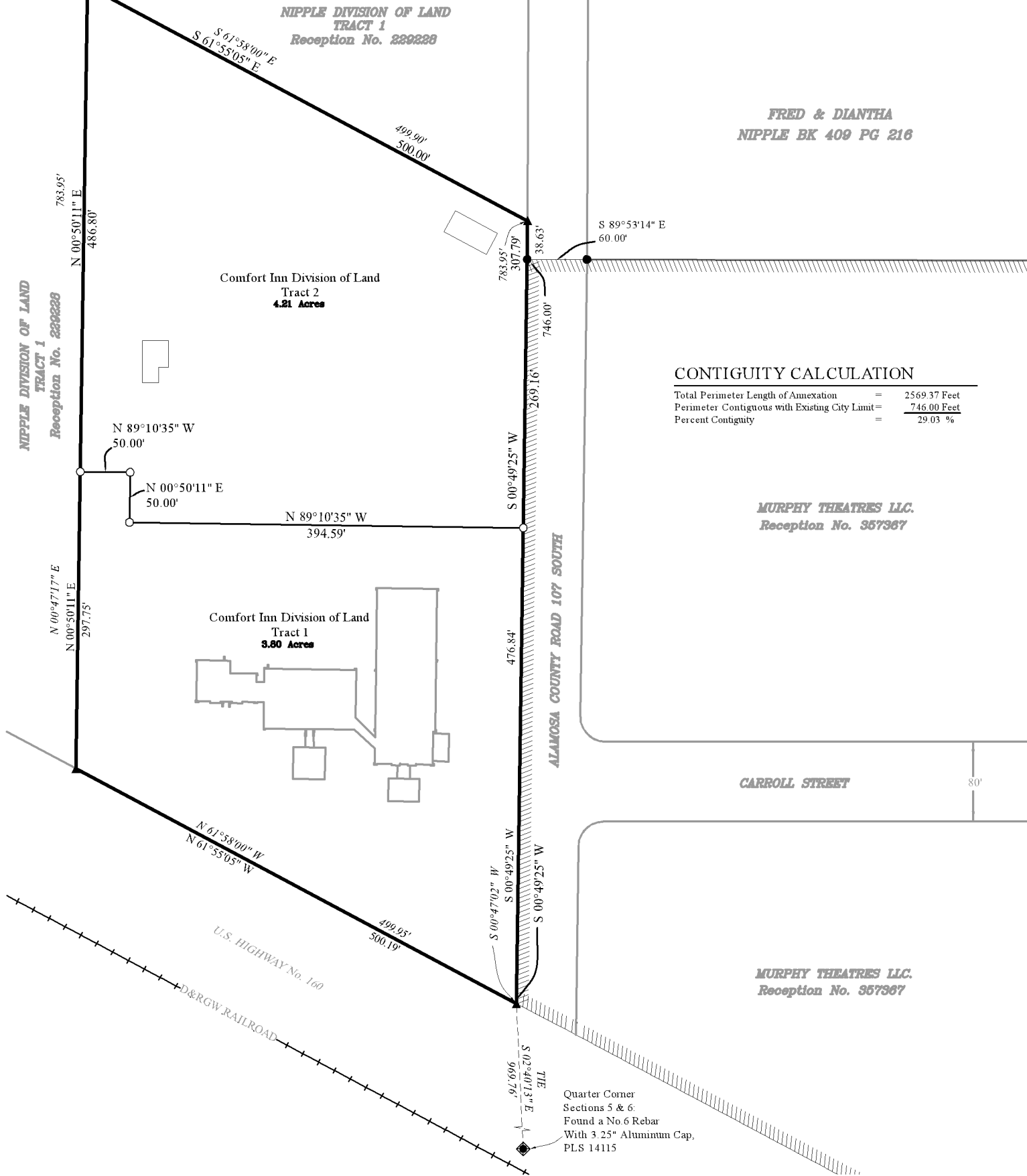

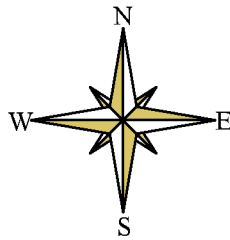

Location Map

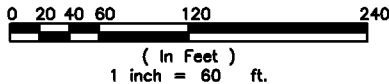
