There were 5 new sales tax licenses added, 3 were outside Alamosa. **Please see following Notes:**

General Fund Accounts Receivable**

Due to the timing of the deposit of sales tax collected by the State on the City's behalf, I will record a monthly accrual for the taxes received. Using August as an example: When the City self-collected the tax, the sales tax collected in July and remitted to the City in August was recorded as August Revenue. Now the July sales tax collections are not received by the City until September. The accrual will keep the monthly revenue consistently reported, and assure there is an accurate 12 month period of revenue on the financial statements.

Enterprise Fund Accounts Receivable****

Utility bills are due the last day of the month. Since the last day of August was on Saturday, a large number of payments were collected on line and in the drop box at City Hall. All of these payments were recorded on September 2, 2019. That is the reason for the substantial increase in the Enterprise Fund accounts receivable as of August 31, 2019.

Enterprise Fund Revenue ***

In 2018 there was a transfer of \$1.8M from the Enterprise Debt Fund included in revenue.

Councilor Daniel moved, seconded by Councilor Broyles to approve Ordinance No. 22-2019 on first reading and set for a public hearing on Wednesday, October 2, 2019 at 7:00 p.m. or as soon thereafter as the matter may be heard. The motion carried unanimously.

Recommended Action:

Approve the City Attorney 2019/2020 contract.

Background:

Pursuant to Council direction, the City Attorney's renewal contract is on the same compensation basis as the existing contract, which expired July 31, 2019, subject to COLA or other increases generally applicable to all City employees within the same pay grade. Staff has recommended that all four Council reports (City Manager, City Clerk, Municipal Judge, and City Attorney) be put on the same contract schedule, terminating October 31, so that a seated Council has the maximum opportunity to perform the annual evaluations. This contract therefore runs for 15 months, from August 1, 2019, to October 31, 2020.

Issue Before the Council:

Does Council wish to approve the proposed City Attorney contract?

Alternatives:

- 1) Approve the contract as presented
- 2) Make changes to the contract, such as
 - a) to the term, picking a different common term for all 4 direct reports;
 - b) to the term, keeping employment terms of direct reports staggered;
 - c) to the amount of compensation, so long as remaining within the range established for the applicable pay grade;
 - d) to other items covered in the contract, such as cell phone allowance

PROFESSIONAL EMPLOYMENT AGREEMENT
CITY ATTORNEY, 2019/2020

This agreement, effective the 1st day of August, 2019, by and between City of Alamosa, Colorado, a Colorado home rule city, (hereinafter "City") and Erich Schwiesow (hereinafter "City Attorney"),

WITNESSETH:

THAT WHEREAS, City is a home-rule, council-manager city under the laws of the State of Colorado; and

WHEREAS, City desires to secure the services of City Attorney as the chief legal officer for the City of Alamosa pursuant to Art. VII of the Alamosa City Charter, and City Attorney agrees to accept such employment from City;

NOW THEREFORE, in and for the mutual promises and agreements hereinafter set forth, and other good and valuable consideration, the sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Employment: City hereby employs, engages, and hires City Attorney as the chief legal officer for City, and City Attorney hereby accepts and agrees to such hiring, engagement and employment, subject to the general supervision and pursuant to the directions of City Council. The nature of the duties of City Attorney will be to faithfully represent the interest of the City as its general counsel for the period designated in the following paragraph, as set forth in Article VII of the Alamosa Charter and as directed by the City Ordinances and the City Council.

2. Term of Employment: The term of this agreement shall be for 15 months, from August 1, 2019 to October 31, 2020, subject to early termination as provided below, and renewed annually thereafter, unless terminated or non-renewed.

3. Compensation: City Attorney shall be paid a salary for this contract term of \$96,000 per year. City Attorney shall be evaluated near the end of the contract term by City Council. Any merit increase available to general employees will be available to City Attorney in the same manner. This does not preclude any changes based on market adjustments.

City Attorney shall receive the following benefits and additional compensation:

a. For City Attorney and dependents, insurance for health care, including primary care, hospitalization, dental, eye-care and prescription coverage shall be available through the partially self-funded City plan, on the shared-cost basis applicable to employees of the City generally.

b. City shall provide City Attorney with group-term life insurance coverage in accordance with the coverage afforded to employee participants of

the City's health care plan, as part of said plan, with the death benefit amount tied to salary level.

c. Mandated contributions to PERA.

d. City Attorney shall be entitled to receive the same cost of living adjustment (COLA) provided to city employees in general by the City Council in addition to any other compensation provided by Council.

e. City shall allow for compensated personal/vacation leave at the maximum rate in accordance with the schedule accruing to employees of the City. (120.12 hours per year, capped at 260 accumulated hours). City Attorney shall notify City Council and City Manager when planning on being away for one week or more. Said leave may be taken at the discretion of City Attorney, subject, however, to City Attorney timing the same so as to meet all of his essential duties, but recognizing that the City may occasionally be required to obtain special counsel to cover regular meetings or other instances requiring legal services that arise during City Attorney's scheduled vacation or any illness.

f. City Attorney will be eligible for all City paid holidays. This position is exempt under the Fair Labor Standards Act, and does not earn overtime. However, City Attorney shall be eligible for 80 hours per calendar year of Administrative Leave Time, as is available to other exempt employees.

g. Upon commencing full-time employment on January 1, 2019, City Attorney gained access to a bank of 30 sick leave days to be used in the case of serious medical conditions. City Attorney shall accrue sick leave and be eligible for Sick Bank benefits, if any, in accordance with the schedule accruing to employees of the City generally, and as delineated, from time to time, in the City's administrative policies. The bank of 30 hours shall be reduced one-to-one as sick leave accrues pursuant to the City's administrative policies.

h. City agrees to budget and to pay for the professional dues, subscriptions, travel and lodging expenses of City Attorney necessary for full participation in state and local associations and organizations reasonably necessary and desirable for his continued professional participation, growth, and advancement, and for the good of the City.

i. City Attorney shall be reimbursed for all reasonable and necessary out-of-pocket expenses incurred in performing his duties hereunder, including expenses for reasonably required continuing professional education and training, subject to review and approval, from time to time, by City Council

m. City Attorney shall have a monthly cell phone allowance of sixty five dollars (\$65.00) paid by City to City Attorney. The City Attorney is responsible for obtaining and maintaining cell phone service.

4. Termination: Either party may terminate this agreement upon providing the other

party thirty (30) days written notice thereof. In the event the City Attorney is terminated and such termination is either (i) by the City without Cause (as defined below), (ii) by the City Attorney due to the existence of a condition constituting Good Reason (as defined below) or (iii) due to a non-renewal without Cause by the City of this Agreement, the City Attorney shall be entitled to (i) a lump sum severance payment equal to six (6) months' salary; (ii) reimbursement of six (6) months of COBRA premiums (or similar premiums if COBRA is not available) if City Attorney timely elects such COBRA coverage ; plus (iii) the City Attorney's accrued vacation; and (iv), the City Attorney's unused sick leave paid in accordance with the employee policy manual. Should such termination at the initiative of the City be for Cause, City Attorney shall be entitled to remain on the City health plan for the month in which he is terminated, plus receive a lump sum payment of (i) the unpaid balance of his salary plus any retirement benefits for the month in which he is terminated; (ii), accrued vacation and unused sick leave paid in accordance with the employee policy manual; and (iii) salary, but no benefits or vacation, for the succeeding calendar month. Such lump sum severance payments shall be paid no later than sixty (60) days following the date City Attorney's employment is terminated. If City Attorney terminates his employment unless for Good Reason, the City Attorney is not entitled to any severance payment.

For purposes of this agreement, a termination of employment will be determined consistent with the rules relating to a "separation from service" as defined in Section 409A of the Internal Revenue Code and the regulations thereunder ("Section 409A"). To the extent that any provision of this agreement is ambiguous as to its compliance with Section 409A, the provision will be read in such a manner so that all payments hereunder comply with Section 409A. To the extent any payment under this paragraph 4 of this agreement may be classified as a "short-term deferral" within the meaning of Section 409A, such payment shall be deemed a short-term deferral, even if it may also qualify for an exemption from Section 409A under another provision of Section 409A. Payments pursuant to this section are intended to constitute separate payments for purposes of Section 1.409A-2(b)(2) of the Treasury Regulations. Except as otherwise expressly provided herein, to the extent any expense reimbursement or the provision of any in-kind benefit under this Agreement is determined to be subject to Section 409A of the Code, the amount of any such expenses eligible for reimbursement, or the provision of any in-kind benefit, in one calendar year shall not affect the expenses eligible for reimbursement in any other taxable year (except for any lifetime or other aggregate limitation applicable to medical expenses), in no event shall any expenses be reimbursed after the last day of the calendar year following the calendar year in which the City Attorney incurred such expenses, and in no event shall any right to reimbursement or the provision of any in-kind benefit be subject to liquidation or exchange for another benefit.

CAUSE. For purposes of this Agreement the term "Cause" is defined as follows:

(a) Any willful, knowing, grossly negligent, or negligent breach, disregard or habitual neglect of any provision of this Agreement, or any willful, knowing, grossly

negligent, or negligent breach, disregard or habitual neglect of any duty or obligation required to be performed by City Attorney under this Agreement or under the Charter and ordinances of the City and/or the laws of the United States or the State of Colorado, including any failure to remain in good standing to practice law in the State of Colorado.

(b) Any misconduct of the City Attorney involving an act of moral turpitude, criminal illegality (excepting minor traffic violations), or habitual violations of the traffic laws related to City Attorney's official duties hereunder.

(c) Any willful, knowing, grossly negligent, or negligent misapplication or misuse, direct or indirect, by City Attorney of public or other funds or other property, real, personal, or mixed, owned by or entrusted to the City, any agency or corporation thereof, or the City Attorney in his official capacity.

GOOD REASON. For purposes of this Agreement the term "Good Reason" is defined as follows:

(a) Any material diminution in the City Attorney's base compensation or benefits (unless City-wide reduction in benefits) without City Attorney's consent.

(b) Any material diminution in the City Attorney's authority, duties, or responsibilities with the City.

(c) Any other action or inaction that constitutes a material breach by the City of any agreement under which the City Attorney provides services to the City.

The City Attorney must provide written notice to the City of the existence of any condition that constitutes Good Reason described above within 90 days of the initial existence of the condition, and upon such the notice the City shall have 30 days to remedy the condition. If the City remedies the condition that constituted Good Reason within 30 days of receiving notice of the condition from the City Attorney, there shall be deemed no Good Reason.

5. External Activities: City Attorney shall devote sufficient time to the job as City Attorney to faithfully discharge his required duties. It is understood that City Attorney is free to contract for similar services to be performed for others while under contract with City so long as City Attorney is able to fully satisfy his obligations under this Agreement, however it is further understood that City Attorney shall limit any such legal services performed for others after January 1, 2019, to wrapping up any matters entered into prior to execution of this Agreement.

6. Conflicts of Interest: City Attorney shall endeavor to avoid all conflicts of interest as provided in the Colorado Rules of Professional Conduct. In the event of a conflict of interest that cannot be avoided or is not waived by the parties involved, City Attorney will not represent either party involved in the conflict and will work with City to secure appropriate special counsel. Among other situations, the Parties recognize that there is the

potential for inherent conflicts of interest any time the City Attorney would serve as both prosecutor and hearing officer (such as in liquor license violation hearings), and that in the event of such a conflict, City Council will determine which role it desires City Attorney to perform and will engage special counsel to perform any necessary other role.

7. Indemnification: In addition to that required under state or local law, City shall defend, save harmless and indemnify City Attorney against any tort, professional liability claim or demand or other legal action, whether groundless or otherwise, arising out of an alleged act or omission occurring in the performance of Employee's duties as City Attorney, unless such claim is the result of intentional misconduct on the part of City Attorney. City may compromise and settle any claim or suit and pay the amount of any settlement or judgment rendered thereon. This indemnification will survive the termination of this agreement.
