Authorization of Series 2010 2/15/2020 payment in the amount of \$392,018.75

Recommended Action:

Staff recommends that Council authorize the Series 2010 2/15/2020 payment in December of 2019.

Background:

Council approved on second reading at the November 6, 2019 meeting Ordinance 27-2019 authorizing the execution of several documents and actions in connection with retiring/refinancing lease purchase agreements entered into in 2010 and 2017 in order to realize significant monetary savings. Since that time staff has been working with Northland Securities, Inc. and other entities to ensure all proper documents have been created and to move this direction forward.

As we wrap up the final details, Northland has recommended that we prepay the February 15th payment in December of this year, at the closing of the re-financing.

The Series 2010 2/15/2020 payment - \$392,018.75 - must be made at closing to allow for the proper transfer of collateral from the 2010 COPs to the Series 2019 COPs. Including it in the Series 2019 COPs only increases the size of the transaction – and some upfront fees along with it. Since we expect to close within two months of that payment, it's almost impossible to generate savings. In fact, savings actually decrease when including it in the refinancing. It's actually a non-callable maturity (i.e. it matures before or on the call date). So, it's more efficient to make the payment as the City would budget normally (if there was no refunding).

The approved 2020 Budget includes this payment and the current fund balance has enough funds to allow for us to make the payment 2 months early. The final budget amendment for the 2019 budget will be presented to Council at the December 18 meeting, and will include this change if approved by Council.

Issue Before the Council:

Does Council wish to authorize the early payment of the Series 2010 2/15/2020 payment?

Alternatives:

- 1) Authorize the early payment;
- 2) Decline to authorize the early payment. As noted above, this will result in increased up-front costs of the issuance of the refunding certificates.

Fiscal Impact:

The \$392,018.75 payment due February 15, 2020 was included in the adopted 2020 budget. The General Fund balance is sufficient to allow for this payment to be made in December. Making the payment early will result in increased overall savings for the refunding series 2019 certificates.

Legal Opinion:

The City Attorney will be present for any questions.

Conclusion:

Authorizing staff to make the payment early is the last Council action needed in order to move forward with the refinancing. The ACLC will be convened to approve the final documents. The Mayor has already been authorized to sign them on behalf of the City.

Subject/Title:

Motion to Authorize the Replacement and Purchase of a Parks Utility Vehicle Not Included in the 2019 CIP.

Recommended Action:

Staff recommends that Council authorize staff to purchase of a new utility vehicle.

Background:

On Monday, July 8th, Parks staff discovered a John Deere "Gator" utility vehicle was stolen over the weekend from the Lee Ball Fields storage area. To date, the vehicle has not been located and the City has filed and received a \$5,995 claim for the vehicle.

In addition to summer ballfield duties, this Gator was also used to plow some City sidewalks and building entryways. Both the City's Fleet Manager and Parks and Recreation Director have been looking for a comparable used vehicle in the region for months and nothing has warranted further investigation. With the oncoming winter snows already starting; it is staff's recommendation to go ahead and purchase a new one to meet current and upcoming maintenance requirements within the City.

Issue Before the Council:

Does Council wish to authorize staff to purchase a new parks utility vehicle?

Alternatives:

While Council is free to select or develop any number of alternatives, those listed below are examples.

1. Authorize staff to purchase a new Parks utility vehicle.
2. Decline to act at this time and give staff further direction

Fiscal Impact:

The cost of a new Utility Vehicle is \$13,600 including a hydraulic plow attachment. Insurance provided \$5,995 leaving \$7,605 as a balance. Staff proposes paying for the vehicle from the general fund using recent fund balance interest that has been greater than anticipated. If authorized to purchase the vehicle, staff will bring a budget amendment forward at December 18th.

Legal Opinion:

City Attorney will be present if there are any legal questions regarding this action.

Conclusion:

Staff has done the due diligence in attempting to replace the stolen equipment efficiently. A new Gator will mean less maintenance and better performance with two core functions of the Parks Department: snow removal and ballfield maintenance.
